10 TO BE ENTITLED  
11 AN ACT

13 Relating to Morgan County; to provide for the  
14 allocation and expenditure of money received from the  
15 Tennessee Valley Authority and distributed to Morgan County  
16 pursuant to Act 2010-135, 2010 Regular Session (Acts 2010, p.  
17 190), for certain fiscal years; and to ratify and confirm any  
18 payments made pursuant to Act 2014-109 of the 2014 Regular  
19 Session (Acts 2014, p. 186).

20 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

21 Section 1. Notwithstanding any other provision of  
22 law, after the allocation of the proceeds pursuant to Act  
23 2013-199 of the 2013 Regular Session, any remaining proceeds  
24 allocated to Morgan County pursuant to Act 2010-135, 2010  
25 Regular Session (Acts 2010, p. 190), from the in-lieu-of-taxes  
26 payments made by the Tennessee Valley Authority shall be  
27 distributed as follows:

1           (1) For the fiscal years beginning October 1, 2018,  
2           October 1, 2019, October 1, 2020, and October 1, 2021, the  
3           remaining proceeds up to a total of three hundred thirty  
4           thousand dollars (\$330,000) each year shall be distributed to  
5           the Community Foundation of Greater Decatur, Inc., to be  
6           distributed by the community foundation based on  
7           recommendations for expenditure from the member representing  
8           each House of Representatives District and the Senate District  
9           comprised of territory in Morgan County as follows: The funds  
10          shall be divided into two shares, with one share to be  
11          expended in the Senate District and one share to be expended  
12          in the House of Representatives Districts based on the  
13          approximate population of each House of Representatives  
14          District in Morgan County as a percentage of the total  
15          population of Morgan County.

16           (2) Any distributions pursuant to subdivision (1)  
17          shall be at the sole discretion of the Community Foundation of  
18          Greater Decatur, Inc.

19           (3) After payment of the above distribution each  
20          year, any remainder shall be distributed each year to the  
21          Morgan County legislative delegation office.

22           Section 2. Any payments made pursuant to Act  
23          2014-109 of the 2014 Regular Session (Acts 2014, p. 186) are  
24          ratified and confirmed.

25           Section 3. This act shall become effective  
26          immediately following its passage and approval by the  
27          Governor, or its otherwise becoming law.
