ENROLLED, An Act,

To alter, rearrange, and extend the boundary lines and corporate limits of the municipality of Collinsville in DeKalb County.

BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. The boundary lines and corporate limits of the municipality of Collinsville in DeKalb County are altered, rearranged, and extended to include within the corporate limits of the municipality, in addition to the lands now included, all of the following territory:

PARCEL NO. 1

Commencing at the NW corner of Section 10, Township 9 South, Range 7 East of the Huntsville Meridian run south along the west line of the said section to the SW corner of the NW 1/4; thence east along the south line of the NW 1/4 to the westerly right-of-way line of Interstate Highway No. 59; thence northeasterly with the said right-of-way 1,150 ft. to the point of beginning.

Thence continue northeasterly with the said interstate right-of-way 2,230 ft. more or less to an angle point in the said right-of-way; thence continue northeasterly with the said right-of-way to a point on the existing town limits and the center of Little Wills Creek; thence northwesterly with the said creek and existing town limits 150

1 ft. more or less; thence leaving the said creek run
2 southwesterly with the said existing town limits 3,050 ft.
3 more or less to an angle point in the said existing town
4 limits; thence southeasterly with the said town limits 740 ft.
5 more or less to an angle point in the existing town limits;
6 thence northeasterly with the said town limits 600 ft. more or
7 less to an angle point in the existing town limits; thence
8 southeasterly with the said town limits 930 ft. more or less
9 to the point of beginning.

10 Said property lying in the north 1/2 of the NE 1/4
11 and in the NE 1/4 of the NW 1/4 in Section 10, and in the
12 south 1/2 of the SE 1/4 of Section 3 all in Township 9 South,
13 Range 7 East of the Huntsville Meridian in DeKalb County,
14 Alabama.

15 AND ALSO

16 Beginning at the NW corner of Section 10, Township 9
17 South, Range 7 East of the Huntsville Meridian run south along
18 the west line of the said section 25.3 ft. more or less to a
19 point on the existing town limits; thence southeasterly with
20 the said town limits 950 ft. more or less to an angle point in
21 the said existing town limits; thence northeasterly with the
22 said town limits 425 ft. more or less; thence leaving the said
23 town limits run northwesterly 1,130 ft. more or less; thence
24 run southwesterly 410 ft. more or less to the point of
25 beginning.

1 Said property lying in the NW 1/4 of the NW 1/4 of
 2 Section 10 and in the SW 1/4 of the SW 1/4 of Section 3 all in
 3 Township 9 South, Range 7 East of the Huntsville Meridian in
 4 DeKalb County, Alabama.

5 PARCEL NO. 2

6 Commencing at the SW corner of Section 3, Township 9
 7 South, Range 7 East of the Huntsville Meridian run north along
 8 the west line of the said section 1,196 ft. more or less to a
 9 point marking the SW corner of Tract No. 9 of the I.J. Cagle
 10 Farm Subdivision, a plat or map of which is recorded in Plat
 11 Book 1, Pages 177 and 178 in the Office of the Judge of
 12 Probate of DeKalb County, Alabama; thence east along the south
 13 line of the said tract No. 9 for a distance of 1,642 ft. more
 14 or less to the SE corner of the said Tract No. 9 for a point
 15 of beginning.

16 Thence north along the east line of Tract No.'s 9,
 17 10 and 11 of the said Cagle Farm Subdivision 1,450 ft. more or
 18 less to the NE corner of Tract No. 11 and the north line of
 19 the NE 1/4 of the SW 1/4 of Section 3; thence east along the
 20 north line of the said forty and Tract No. 12 of the said
 21 Cagle Farm Subdivision 200 ft. more or less to the center of
 22 Little Wills Creek; thence run southeasterly with the said
 23 creek to a point on the east line of the Tract No. 12 of the
 24 said Cagle Farm Subdivision; thence south along the east line
 25 of the said Tract No. 12 to the SE corner thereof; thence west

1 along the south line of Tract No. 12 for a distance of 700 ft.
 2 more or less to the point of beginning.

3 Said property lying in the East 1/2 of the SW 1/4 of
 4 Section 3, Township 9 South, Range 7 East of the Huntsville
 5 Meridian in DeKalb County, Alabama.

6 PARCEL NO. 3

7 Beginning at the NW corner of Section 14, Township 9
 8 South, Range 7 East of the Huntsville Meridian run south along
 9 the west line of Section 14 to the SW corner of the NW 1/4 of
 10 the NW 1/4; thence east along the south line of the said forty
 11 950 ft. more or less to a point on the existing town limits;
 12 thence continue along the south line of the NW 1/4 of the NW
 13 1/4 and the NE 1/4 of the NW 1/4 with the existing town limits
 14 1,150 ft. more or less to an angle point in the existing town
 15 limits, said point being on the west line of the Collinsville
 16 Cemetery Property; thence north with the said existing town
 17 limits and the Collinsville Cemetery Property to the NW corner
 18 of the said cemetery property; thence east with the said
 19 cemetery property and existing town limits to the NE corner of
 20 the said cemetery property; thence south with the said
 21 cemetery property and existing town limits to a point on the
 22 north margin of Gym Street (Cemetery Circle); thence
 23 southeasterly with the north margin of the said street to a
 24 point on the east line of the NE 1/4 of the NW 1/4 of the said
 25 section; thence north along the east line of the said NE 1/4

1 of the NW 1/4 and existing town limits to a point on the north
2 line of the said Section 14; thence west along the north line
3 of the said section to the point of beginning.

4 Said property lying in the north 1/2 of the NW 1/4
5 of Section 14, Township 9 South, Range 7 East of the
6 Huntsville Meridian in DeKalb County, Alabama.

7 PARCEL NO. 4

8 Beginning at the NE corner of the SE 1/4 of Section
9 14, Township 9 South, Range 7 East of the Huntsville Meridian
10 run west along the north line of the said SE 1/4 and the
11 existing town limits to a point on the westerly right-of-way
12 line of the Alabama Great Southern Railroad; thence
13 southwesterly with the said railroad right-of-way and the
14 existing town limits 460 ft. more or less; thence leaving the
15 said railroad and existing town limits run east to a point on
16 the east line of Section 14; thence north along the east line
17 of Section 14 to the point of beginning.

18 Said property lying in the north 1/2 of the SE 1/4
19 of Section 14, Township 9 South, Range 7 East of the
20 Huntsville Meridian in DeKalb County, Alabama.

21 Section 2. In accordance with Section 11-42-6(b) of
22 the Code of Alabama 1975, a map showing what territory is
23 proposed to be annexed to the municipality of Collinsville is
24 on file in the office of the Judge of Probate in DeKalb

1 County, Alabama, and the map is open to the inspection of the
2 public.

3 Section 3. This act shall become effective on the
4 first day of the third month following its passage and
5 approval by the Governor, or its otherwise becoming law.
