7 WHEREAS, it is with highest commendation that we 8 recognize Deputy Justin Billa as a recipient of the 2019 9 Alabama Legislative Medal of Honor for Law Enforcement, 10 Alabama's highest law enforcement award for extraordinary 11 courage in the line of duty; and

WHEREAS, on February 20, 2018, Deputy Justin Billa 12 13 tragically lost his life while responding to a crime at the 14 Ridge Road West area in Mobile, Alabama, where Deputy Billa 15 and other police found a female body, identified as Fonda 16 Poellnitz; through continued investigation, detectives 17 followed up on the whereabouts of Poellnitz's ex-husband, 18 Robert Hollie; police responded to Hollie's residence and 19 observed a vehicle that belonged to Hollie in the driveway; 20 while waiting for additional officers to set up perimeter, 21 Hollie emerged and fired multiple shots, with one round 22 striking Officer Billa; Officer Billa was immediately removed 23 from the scene and transported to the hospital, where he later 24 died; soon thereafter, SWAT members found Hollie deceased 25 inside the residence from a self-inflicted gunshot wound; and
