24	Section 1. Section 32-5A-260, Code of Alabama 1975,
25	is amended to read as follows:

## "Every Except as provided in Section 32-5A-267,

2 <u>every</u> person riding a bicycle upon a roadway shall be granted 3 all of the rights and shall be subject to all of the duties 4 applicable to the driver of a vehicle by this chapter, except 5 as to special regulations in this article and except as to 6 those provisions of this chapter which by their nature can 7 have no application."

8 Section 2. Section 32-5A-267 is added to the Code of 9 Alabama 1975, to read as follows:

§32-5A-267.

(a) A bicycle operator approaching a stop sign at an intersection with a roadway having three or more lanes for moving traffic shall come to a complete stop before entering the intersection.

(b) A bicycle operator approaching a stop sign at an intersection where a vehicle is stopped in the roadway at the same stop sign shall come to a complete stop before entering the intersection.

(c) A bicycle operator approaching a stop sign at an 19 20 intersection with a roadway having two or fewer lanes for 21 moving traffic shall reduce speed and, if required for safety, stop before entering the intersection. After slowing to a 22 23 reasonable speed or stopping, the person shall yield the 24 right-of-way to any vehicle in the intersection or approaching 25 on another roadway so closely as to constitute an immediate 26 hazard during the time the person is moving across or within the intersection. 27

(d) A bicycle operator approaching an intersection
 shall always yield the right-of-way to any vehicle which has
 already entered the intersection.

4 (e) When a bicycle and a vehicle enter an
5 intersection from different roadways at approximately the same
6 time, the operator of the vehicle or bicycle on the left shall
7 yield the right-of-way to the vehicle or bicycle on the right.

8 Section 3. This act shall become effective on the 9 first day of the third month following its passage and 10 approval by the Governor, or its otherwise becoming law.
