4 SYNOPSIS:

5 Under existing law, a person commits the crime 6 of possession of obscene matter if he or she knowingly 7 possesses any obscene matter that contains a visual 8 depiction of a person under the age of 17 years engaged 9 in any act of sado-masochistic abuse, sexual 10 intercourse, sexual excitement, masturbation, breast 11 nudity, genital nudity, or other sexual conduct.

12 This bill would provide that a person commits the crime of trafficking in obscene matter if he or she 13 14 possesses 25 or more items of obscene matter that 15 contains a visual depiction of an individual under 17 years of age engaged in any act of sado-masochistic 16 17 abuse, sexual intercourse, sexual excitement, 18 masturbation, breast nudity, genital nudity, or other sexual conduct. 19

20This bill would also provide penalties for21violations.

## SB320 INTRODUCED



29 13A-12-192, Code of Alabama 1975; to provide for the offense 30 of trafficking in obscene material; and to provide penalties 31 for violations.

32 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

33 Section 1. Section 13A-12-192, Code of Alabama 1975, is 34 amended to read as follows:

"§13A-12-192

36 (a) Any person who knowingly possesses with intent to 37 disseminate any obscene matter that contains a visual depiction of a person under the age of 17 years engaged in any 38 39 act of sado-masochistic abuse, sexual intercourse, sexual excitement, masturbation, breast nudity, genital nudity, or 40 other sexual conduct shall be quilty of a Class B felony. Any 41 42 transfer of the visual depiction from any electronic device to 43 any other device, program, application, or any other place with storage capability which can be made available or is 44 45 accessible by other users, is prima facie evidence of 46 possession with intent to disseminate.

(b) Any person who knowingly possesses any obscene matter that contains a visual depiction of a person under the age of 17 years engaged in any act of sado-masochistic abuse, sexual intercourse, sexual excitement, masturbation, breast nudity, genital nudity, or other sexual conduct shall be guilty of a Class C felony.

53 (c) Any person who knowingly possesses 25 or more items 54 of obscene matter that contain a visual depiction of an 55 individual under 17 years of age engaged in any act of 56 sado-masochistic abuse, sexual intercourse, sexual excitement,

- 57 masturbation, breast nudity, genital nudity, or other sexual
- 58 conduct shall be guilty of trafficking in obscene material.
- 59 Trafficking in obscene material is a Class B felony."
- 60 Section 2. This act shall become effective on October
