20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
21

22 SECTION 1. REGULAR SALARIES. There is hereby established for the
23 Auctioneers Licensing Board for the 2016-2017 fiscal year, the following
24 maximum number of regular employees.

33 SECTION 2. EXTRA HELP. There is hereby authorized, for the Auctioneers
34 Licensing Board for the 2016-2017 fiscal year, the following maximum number
35 of part-time or temporary employees, to be known as "Extra Help", payable
36 from funds appropriated herein for such purposes: one (1) temporary or part-



1 time employees, when needed, at rates of pay not to exceed those provided in
 2 the Uniform Classification and Compensation Act, or its successor, or this
 3 act for the appropriate classification.

4
 5 SECTION 3. APPROPRIATION - OPERATIONS. There is hereby appropriated,
 6 to the Auctioneers Licensing Board, to be payable from cash funds as defined
 7 by Arkansas Code 19-4-801 of the Auctioneers Licensing Board, for personal
 8 services and operating expenses of the Auctioneers Licensing Board for the
 9 fiscal year ending June 30, 2017, the following:

 26 SECTION 4. EMPLOYMENT OF ATTORNEYS. None of the funds appropriated in
 27 this Act for Maintenance and General Operation shall be expended in payment
 28 for services of attorneys, unless the agency shall first make a request in
 29 writing to the Attorney General of the State of Arkansas to provide the
 30 required legal services. The Attorney General's Office shall provide the
 31 requested legal services, or, if the Attorney General's Office shall
 32 determine that sufficient personnel are not available to provide the
 33 requested legal services, the Attorney General shall certify the same to the
 34 agency and may authorize the agency to employ legal counsel and to expend
 35 monies appropriated for Maintenance and General Operations therefor, if:

- 36 (1) The Attorney General determines, and certifies in writing, that

1 such agency needs the advice or assistance of legal counsel, and

2 (2) The Attorney General consents in writing to the employment of the
 3 legal counsel to be retained by the agency.

4 Such certification shall be required with respect to each instance of
 5 the employment of special legal counsel, or shall be required annually with
 6 respect to legal counsel employed on a retainer basis. A copy of such
 7 certification shall be entered in the official minutes of the agency, and
 8 shall be retained in the fiscal records of the agency for audit purposes.

9
 10 SECTION 5. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
 11 authorized by this act shall be limited to the appropriation for such agency
 12 and funds made available by law for the support of such appropriations; and
 13 the restrictions of the State Procurement Law, the General Accounting and
 14 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
 15 Procedures and Restrictions Act, or their successors, and other fiscal
 16 control laws of this State, where applicable, and regulations promulgated by
 17 the Department of Finance and Administration, as authorized by law, shall be
 18 strictly complied with in disbursement of said funds.

19
 20 SECTION 6. LEGISLATIVE INTENT. It is the intent of the General
 21 Assembly that any funds disbursed under the authority of the appropriations
 22 contained in this act shall be in compliance with the stated reasons for
 23 which this act was adopted, as evidenced by the Agency Requests, Executive
 24 Recommendations and Legislative Recommendations contained in the budget
 25 manuals prepared by the Department of Finance and Administration, letters, or
 26 summarized oral testimony in the official minutes of the Arkansas Legislative
 27 Council or Joint Budget Committee which relate to its passage and adoption.

28
 29 SECTION 7. EMERGENCY CLAUSE. It is found and determined by the General
 30 Assembly, that the Constitution of the State of Arkansas prohibits the
 31 appropriation of funds for more than a one (1) year period; that the
 32 effectiveness of this Act on July 1, 2016 is essential to the operation of
 33 the agency for which the appropriations in this Act are provided, and that in
 34 the event of an extension of the legislative session, the delay in the
 35 effective date of this Act beyond July 1, 2016 could work irreparable harm
 36 upon the proper administration and provision of essential governmental

1 programs. Therefore, an emergency is hereby declared to exist and this Act
2 being necessary for the immediate preservation of the public peace, health
3 and safety shall be in full force and effect from and after July 1, 2016.
