5	authorized by this act shall be limited to the appropriation	for such agency

7	the restrictions of the State Procurement Law, the General Accounting and			
8	Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary			
9	Procedures and Restrictions Act, or their successors, and other fiscal			
10	control laws of this State, where applicable, and regulations promulgated by			
11	the Department of Finance and Administration, as authorized by law, shall be

14	SECTION 3. LEGISLATIVE INTENT. It is the intent of th	e General		
15	Assembly that any funds disbursed under the authority of the	appropriations		
16	contained in this act shall be in compliance with the stated reasons for			
17	which this act was adopted, as evidenced by the Agency Reque	sts, Executive		
18	Recommendations and Legislative Recommendations contained in	the budget		
19	manuals prepared by the Department of Finance and Administra	tion, letters, or		
20	summarized oral testimony in the official minutes of the Ark	ansas Legislative		
21	Council or Joint Budget Committee which relate to its passag	e and adoption.

23	SECTION 4. EMERGENCY CLAUSE. It is found and determin	ed by the General		
24	Assembly, that the Constitution of the State of Arkansas pro	hibits the		
25	appropriation of funds for more than a one (1) year period;	that the		
26	effectiveness of this Act on July 1, 2012 is essential to the	e operation of		
27	the agency for which the appropriations in this Act are prov	ided, and that in		
28	the event of an extension of the legislative session, the de	lay in the		
29	effective date of this Act beyond July 1, 2012 could work ir	reparable harm		
30	upon the proper administration and provision of essential go	<u>vernmental</u>		
31	programs. Therefore, an emergency is hereby declared to exis	t and this Act		
32	being necessary for the immediate preservation of the public	peace, health		
33	and safety shall be in full force and effect from and after	July 1, 2012.
