8	(b) Payments for travel or reimbursement for		
9	any expenses are not informational material;		
10	(ii) Gifts which are not used and which, within		
11	thirty (30) days after receipt, are returned to the donor;		
12	(iii) Gifts from the spouse, child, parent,		
13	grandparent, grandchild, brother, sister, parent-in-law, brother-in-law,		
14	sister-in-law, nephew, niece, aunt, uncle, or first cousin of a person		
15	elected to an office under subsection (a) of this section, or the spouse of		
16	any of these persons, unless the person is acting as an agent or intermediary		
17	for any person not covered by this subdivision (b)(1)(B)(iii);
