16 SECTION 2. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 17 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. FUNDING 18 TRANSFER. Immediately upon the effective date of this Act, the Chief Fiscal 19 Officer of the State shall transfer on his or her books and those of the 20 State Treasurer and the Auditor of the State six hundred ninety one thousand 21 five hundred dollars (\$691,500) from the General Revenue Allotment Reserve 22 Fund to the University of Arkansas Fund, there to be used exclusively for the 23 purposes appropriated for by this Act.

SECTION 3. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized by this act shall be limited to the appropriation for such agency and funds made available by law for the support of such appropriations; and the restrictions of the State Procurement Law, the General Accounting and Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary Procedures and Restrictions Act, the Higher Education Expenditures Restrictions Act, or their successors, and other fiscal control laws of this State, where applicable, and regulations promulgated by the Department of Finance and Administration, as authorized by law, shall be strictly complied with in disbursement of said funds.

SECTION 4. LEGISLATIVE INTENT. It is the intent of the General

| 10 | Assembly, that the Constitution of the State of Arkansas prohibits the                            |

| 12 | effectiveness of this Act on July 1, 2013, with the exception that Section $2$                    |
| 13 | in this Act shall be in full force and effect from and after the date of its                      |
| 14 | passage and approval, is essential to the operation of the agency for which                       |
| 15 | the appropriations in this Act are provided; and that in the event of an                          |
| 16 | extension of the legislative session, the delay in the effective date of this                     |
| 17 | Act beyond July 1, 2013, with the exception that Section 2 in this Act shall                      |
| 18 | be in full force and effect from and after the date of its passage and                            |
| 19 | approval, could work irreparable harm upon the proper administration and                          |
