## **Bill Summary**

The bill establishes the task force concerning youth who are experiencing homelessness (task force) to study and make recommendations on issues related to the issue of youth experiencing homelessness in Colorado. The membership of the task force is set forth, as well as reporting requirements and a repeal date.

HOUSE Amended 2nd Reading February 26, 2018 The bill makes conforming amendments to correct citations to an earlier relocation of the office of homeless youth services to the department of local affairs.

(1) (a) THE GENERAL ASSEMBLY 7 FINDS AND DECLARES THAT: 8 (I) MORE THAN EIGHTY-THREE THOUSAND YOUTH BETWEEN THE 9 AGES OF FOURTEEN AND TWENTY-FOUR ARE HOMELESS IN THE UNITED 10 STATES; 11 (II)THE MOST VULNERABLE SEGMENT OF COLORADO'S 12 POPULATION, CHILDREN AND YOUTH, ARE EXPERIENCING HOMELESSNESS 13 AT AN INCREASING RATE; 14 (III) HOMELESSNESS HAS A SIGNIFICANT NEGATIVE IMPACT ON THE 15 WELL-BEING OF INDIVIDUALS, PARTICULARLY THOSE WHO EXPERIENCE IT 16 AT A YOUNG AGE; AND 17 (IV) UNACCOMPANIED CHILDREN AND YOUTH WHO EXPERIENCE 18 HOMELESSNESS EXPERIENCE SIGNIFICANT IMMEDIATE AND LONG-TERM 19 TRAUMA. 20 (b) THEREFORE, THE GENERAL ASSEMBLY DECLARES THAT IT IS IN 21 THE BEST INTERESTS OF THE STATE OF COLORADO TO ESTABLISH A TASK 22 FORCE TO EXAMINE COLORADO'S SYSTEM OF SERVICES AND CREATE AND 23 COORDINATE A STATE PLAN TO SUPPORT BETTER OUTCOMES FOR CHILDREN 24 AND YOUTH WHO ARE EXPERIENCING HOMELESSNESS.
