state agency rules and regulations that were adopted or amended on or after November 1, 2010, and before November 1, 2011, with the exception of the rules and regulations specifically listed in the bill. Those specified rules and regulations will expire as scheduled in the "State Administrative Procedure Act" on May 15, 2012, on the grounds that the rules and regulations either conflict with statute or lack or exceed statutory authority.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1. Rules and regulations scheduled for expiration**

3 **May 15, 2012 - extension.** (1) Except as indicated, the expiration of all  
4 rules and regulations of agencies in the following principal departments,  
5 which rules and regulations were adopted or amended on or after  
6 November 1, 2010, and before November 1, 2011, and that are therefore  
7 scheduled for expiration May 15, 2012, is postponed, and the provisions  
8 of section 24-4-108 or 24-34-104, Colorado Revised Statutes, shall apply:

9 (a) Department of agriculture;

10 (b) Department of corrections;

11 (c) Department of education; except that the following rules of the  
12 state board of education concerning parental notification upon an arrest  
13 made or charges brought against school employee (1 CCR 301-83) are not  
14 extended:

15 (I) Rule 1.00, concerning definitions;

16 (II) Rule 2.00, concerning parental notification;

17 (III) Rule 3.00, concerning notification requirements;

18 (IV) Rule 4.00, concerning list of offenses requiring notification;

19 (d) Department of health care policy and financing;

20 (e) Department of higher education;

21 (f) Department of human services; except that the following rule  
22 of the state board of human services, concerning rule manual volume 3,

1 income maintenance, general requirements for citizenship and lawful  
2 presence (9 CCR 2503-1) is not extended: Rule 3.140.12 D. 14.,  
3 concerning emergency applicants and crisis intervention program under  
4 the low-income energy assistance program (LEAP);

5 (g) Department of labor and employment;

6 (h) Department of law;

7 (i) Department of local affairs;

8 (j) Department of military and veterans affairs;

9 (k) Department of natural resources;

10 (l) Department of personnel; except that the following rules of the  
11 department of personnel concerning the address confidentiality program  
12 (1 CCR 103-6) are not extended:

13 (I) Rule 1.0, concerning introduction;

14 (II) Rule 2.0, concerning definitions;

15 (III) Rule 3.0, concerning application assistant designation;

16 (IV) Rule 4.0, concerning participant telephone number and  
17 address changes;

18 (V) Rule 5.0, concerning expedited release of participant  
19 information to criminal justice officials or agencies;

20 (VI) Rule 6.0, concerning public school enrollment and record  
21 transfers;

22 (m) Department of public health and environment;

23 (n) Department of public safety;

24 (o) Department of regulatory agencies;

25 (p) Department of revenue;

26 (q) Department of state; ■ ■ ■

27 (r) Department of transportation;

1 (s) Department of the treasury.

2 (2) The expiration of all rules and regulations of the public  
3 employees' retirement association, which rules and regulations were  
4 adopted or amended on or after November 1, 2010, and before November  
5 1, 2011, and which are therefore scheduled for expiration May 15, 2012,  
6 is postponed.

7 (3) The expiration of all rules and regulations of the office of  
8 information technology, in the office of the governor, which rules and  
9 regulations were adopted or amended on or after November 1, 2010, and  
10 before November 1, 2011, and which are therefore scheduled for  
11 expiration May 15, 2012, is postponed.

12 (4) The recommendations of the committee on legal services as  
13 reflected in this act apply to the specified rules in the form in which said  
14 rules were considered and acted upon by the committee. Any amendments  
15 or other changes in the specified rules that became effective before  
16 November 1, 2011, that comply with the recommendations of the  
17 committee on legal services are not affected by this act. Any subsequent  
18 amendments or other changes in the specified rules that became effective  
19 on or after November 1, 2011, are not affected by this act.

20 (5) The automatic expiration of the rules of the state board of  
21 education, department of education, concerning the process for  
22 nonprobationary teacher to appeal second consecutive performance  
23 evaluation rating of ineffective or partially effective in the rules for  
24 administration of a statewide system to evaluate the effectiveness of  
25 licensed personnel employed by school districts and boards of cooperative  
26 services (1 CCR 301-87), which rules were adopted on April 11, 2012,  
27 and that are therefore scheduled for expiration May 15, 2013, is

1 postponed, effective May 15, 2012.

2           **SECTION 2. Safety clause.** The general assembly hereby finds,  
3 determines, and declares that this act is necessary for the immediate  
4 preservation of the public peace, health, and safety.
