(1) Persons 4 not eligible for membership in the association include: 5 6 (m) DIRECTORS OF SPECIAL DISTRICTS SERVING PURSUANT TO THE 7 "SPECIAL DISTRICT ACT", ARTICLE 1 OF TITLE 32, WHO BEGIN THEIR 8 SERVICE AS DIRECTORS ON OR AFTER JULY 1, 2022. 9 **SECTION 2.** Safety clause. The general assembly hereby finds, determines, and declares that this act is necessary for the immediate 10 11 preservation of the public peace, health, or safety.
