CONCERNING THE CONTINUATION OF THE NURSE-PHYSICIAN ADVISORY TASK FORCE FOR COLORADO HEALTH CARE, AND, IN CONNECTION THEREWITH, IMPLEMENTING THE RECOMMENDATIONS CONTAINED IN THE 2019 SUNSET REPORT BY THE DEPARTMENT OF REGULATORY AGENCIES, SPECIFYING THE TYPE OF PHYSICIAN ORGANIZATION TO BE REPRESENTED ON THE TASK FORCE, AND MAKING AN APPROPRIATION.

Be it enacted by the General Assembly of the State of Colorado:

**SECTION 1.** In Colorado Revised Statutes, 2-3-1203, **repeal** (11); and **add** (18.5) as follows:

2-3-1203. Sunset review of advisory committees - legislative declaration - definition - repeal. (11) (a) The following statutory authorizations for the designated advisory committees will repeal on September 1, 2020:

- (I) The nurse-physician advisory task force for Colorado health care created in section 12-30-105.
  - (b) This subsection (11) is repealed, effective September 1, 2022.
- (18.5) (a) THE FOLLOWING STATUTORY AUTHORIZATIONS FOR THE DESIGNATED ADVISORY COMMITTEES WILL REPEAL ON SEPTEMBER 1, 2027:
- (I) THE NURSE-PHYSICIAN ADVISORY TASK FORCE FOR COLORADO HEALTH CARE CREATED IN SECTION 12-30-105.
- (b) This subsection (18.5) is repealed, effective September 1, 2029.
- **SECTION 2.** In Colorado Revised Statutes, 12-30-105, **amend** (2)(a)(III)(B) and (7) as follows:
- 12-30-105. Nurse-physician advisory task force for Colorado health care creation duties definition. (2) (a) The NPATCH consists of twelve members appointed as follows:
  - (III) Ten members appointed by the governor as follows:
- (B) Three members LICENSED PHYSICIANS recommended by and representing a statewide physicians' organization THAT REPRESENTS MULTI-SPECIALTY PHYSICIANS AND WHOSE MEMBERSHIP INCLUDES AT LEAST ONE-THIRD OF THE DOCTORS OF MEDICINE AND OSTEOPATHY LICENSED IN THE STATE;
- (7) This section is repealed, effective September 1, 2020 SEPTEMBER 1, 2027. Before the repeal, the functions of the NPATCH are scheduled for review in accordance with section 2-3-1203.
- **SECTION 3. Appropriation.** For the 2020-21 state fiscal year, \$15,554 is appropriated to the department of regulatory agencies for use by the division of professions and occupations. This appropriation is from the division of professions and occupations cash fund created in section 12-20-105 (3), C.R.S., and is based on an assumption that the division will require an additional 0.2 FTE. To implement this act, the division may use this appropriation for personal services.
