CONCERNING THE CONTINUATION OF THE STATUTES GOVERNING HOME WARRANTY SERVICE CONTRACTS, AND, IN CONNECTION THEREWITH, IMPLEMENTING THE RECOMMENDATIONS CONTAINED IN THE 2019 SUNSET REPORT BY THE DEPARTMENT OF REGULATORY AGENCIES.

Be it enacted by the General Assembly of the State of Colorado:

**SECTION 1.** In Colorado Revised Statutes, **amend** 12-10-906 as follows:

**12-10-906.** Repeal of part - subject to review. This part 9 is repealed, effective July 1, 2020 SEPTEMBER 1, 2026. Before the repeal, this part 9 is scheduled for review in accordance with section 24-34-104.

**SECTION 2.** In Colorado Revised Statutes, 24-34-104, add (27)(a)(XVII) as follows:

(XVII) THE LEGAL REQUIREMENTS PERTAINING TO HOME WARRANTY SERVICE CONTRACTS UNDER PART 9 OF ARTICLE 10 OF TITLE 12.

**SECTION 3.** In Colorado Revised Statutes, **amend** 12-10-905 as follows:

**12-10-905. Prohibitions.** It is unlawful for any lending institution to require the purchase of A home warranty insurance SERVICE CONTRACT as a condition for granting financing for the purchase of the home.
