A BILL FOR AN ACT

101 CONCERNING DISCIPLINARY MEASURES IN PUBLIC SCHOOLS.

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. Legislative Task Force to Study School Discipline. The bill amends the statutory grounds for suspension or expulsion of a student to increase the discretion of school administrators and school district boards of education (local boards). The only circumstances under which expulsion remains mandatory are those that involve a student who is determined to have brought a firearm to school or possessed a firearm at school. The bill defines the terms "suspension", "in-school suspension",

"out-of-school suspension", and "expulsion".

The bill relocates, with substantive amendments, certain statutory provisions concerning school conduct and discipline codes (codes) and safe school reporting requirements.

Each code shall include criteria distinguishing minor code violations from behavior that will result in the referral of an offending student to a law enforcement agency. Each code shall include a specific policy concerning the prevention of sexual assault and domestic violence.

Each public school of a school district shall require each student enrolled in the public school to be familiar with the provisions of the code.

In creating and enforcing a code, each local board shall:

- ! Ensure that the code is designed to protect students from harm, provide opportunities for students to learn from their mistakes, foster a positive learning community, keep students in school, and implement a graduated set of age-appropriate responses to misconduct that are fair and proportionate in relation to each student's individual conduct;
- ! To the extent practicable, limit the use of out-of-school suspensions and expulsions to incidents that involve conduct that poses a serious and credible threat to the safety of pupils and staff; and
- ! To the extent practicable, use prevention, intervention, restorative justice, peer mediation, counseling, and other approaches to address student misconduct.

In creating a code, each local board shall solicit and consider input from the school district accountability committee of the school district and a local or statewide law enforcement agency.

To the extent practicable, each local board shall assist teachers and other school employees, as may be appropriate, in obtaining training in conflict resolution in and out of the classroom, disciplinary alternatives, and restorative justice for the purpose of preventing violations of the school district's code.

If a student is suspended from school, the suspending authority shall provide an opportunity for the student to make up school work during the period of suspension for full academic credit.

The report of code violations that is required of each school principal as part of the safe school reporting requirements shall specifically identify each violation that resulted in referral to a law enforcement agency.

On and after October 1, 2012, the peace officer standards and training (P.O.S.T.) board shall create and provide a training curriculum to prepare peace officers to serve as school resource officers. In creating the training curriculum, the P.O.S.T. board shall solicit and, to the extent

practicable, implement the suggestions of relevant stakeholders.

On and after October 1, 2013, neither a school administrator nor a local board shall accept the assignment of a peace officer acting in his or her official capacity as school resource officer in a public school unless the peace officer has successfully completed the school resource officer training program.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1. Legislative declaration.** (1) The general assembly
3 hereby finds that a safe school is one that has a conduct and discipline
4 code that:

5 (a) Defines and helps to create a learning environment that
6 students respect;

7 (b) Defines acceptable norms of behavior for students;

8 (c) Recognizes that a disruptive student infringes on the rights of
9 other students in the school to receive a free and appropriate education;

10 (d) Protects students from the violence and intimidation of
11 bullying by setting forth clear and strict consequences for that type of
12 behavior;

13 (e) Establishes policies and procedures to address behavior that
14 poses a threat to the safety of the students or employees of the school;

15 (f) Establishes a system of consequences for misconduct, which
16 system helps define the culture of the school; and

17 (g) Makes these consequences known by making them easily
18 available and visible to all students.

19 (2) The general assembly further finds that it is important that
20 children of school age recognize that:

21 (a) A safe school enhances student achievement;

22 (b) Respect of law and policies is an important part of a civil

1 society;

2 (c) School administrators and law enforcement officers are their
3 friends, and the laws and policies these persons enforce provide students
4 the opportunity to get a quality education; and

5 (d) They live in a country and a state that ensure them due process
6 for a fair administration of justice in their schools.

7 (3) Finally, the general assembly finds that:

8 (a) Proportionate disciplinary interventions and consequences,
9 including but not limited to in-school suspensions, provide an adequate
10 response to most conduct and discipline code violations;

11 (b) Public schools and school district boards of education should
12 use out-of-school suspensions and expulsions as disciplinary responses
13 to only the most serious offenses; and

14 (c) If a school administrator or a school district board of education
15 deems it necessary to suspend or expel a student from school, the school
16 administrator or board must consider the safety of the other students if
17 and when the student returns to the school.

18 (4) Now, therefore, the general assembly hereby declares that, in
19 creating and enforcing a school conduct and discipline code, each school
20 district board of education shall:

21 (a) Ensure that the code is designed to:

22 (I) Protect students from harm;

23 (II) Provide opportunities for students to learn from their
24 mistakes;

25 (III) Foster a positive learning community;

26 (IV) Keep students in school; and

27 (V) Implement a graduated set of age-appropriate responses to

1 misconduct that are fair and proportionate in relation to each student's
2 individual conduct;

3 (b) To the extent practicable:

4 (I) Impose proportionate disciplinary interventions and
5 consequences, including but not limited to in-school suspensions, in
6 response to student misconduct; and

7 (II) Limit the use of out-of-school suspensions and expulsions to
8 incidents that involve conduct that poses a serious and credible threat to
9 the safety of pupils and staff;

10 (c) To the extent practicable, use prevention, intervention,
11 restorative justice, peer mediation, counseling, and other approaches to
12 address student misconduct; and

13 (d) Ensure the code complies with all state and federal laws
14 concerning the education of students with disabilities, as defined in
15 section 22-20-103 (5), Colorado Revised Statutes.

16 **SECTION 2.** In Colorado Revised Statutes, 22-32-109.1, **amend**
17 (2) (a), (2) (b), and (10) as follows:

18 **22-32-109.1. Board of education - specific powers and duties**
19 **- safe schools. (2) Safe school plan.** In order to provide a learning
20 environment that is safe, conducive to the learning process, and free from
21 unnecessary disruption, following consultation with the school district
22 accountability committee and school accountability committees, parents,
23 teachers, administrators, students, student councils where available, and,
24 where appropriate, the community at large, each school district board of
25 education shall adopt and implement a safe school plan, or review and
26 revise, if necessary, any existing plans or policies already in effect, which
27 shall include, but not be limited to, the following:

1 (a) **Conduct and discipline code.** A concisely written conduct
2 and discipline code that shall be enforced uniformly, fairly, and
3 consistently for all students IN ACCORDANCE WITH THE PROVISIONS OF
4 SECTION 22-32-145 AND ALL OTHER APPLICABLE STATE AND FEDERAL
5 LAWS. Copies of the code shall be provided to each student upon
6 enrollment at the elementary, middle, JUNIOR HIGH, and high school levels
7 and shall be posted or kept on file at each public school in OF the school
8 district. ~~The code shall include, but shall not be limited to:~~
9 ADDITIONALLY, EACH PUBLIC SCHOOL OF THE SCHOOL DISTRICT SHALL
10 REQUIRE EACH STUDENT ENROLLED IN THE PUBLIC SCHOOL TO BE FAMILIAR
11 WITH THE PROVISIONS OF THE CODE.

12 ~~(I) General policies on student conduct, safety, and welfare;~~
13 ~~(H) General policies and procedures for dealing with students who~~
14 ~~cause a disruption in the classroom, on school grounds, in school~~
15 ~~vehicles, as defined in section 42-1-102 (88.5), C.R.S., or at school~~
16 ~~activities or sanctioned events, including a specific policy allowing a~~
17 ~~teacher to remove a disruptive student from his or her classroom and,~~

4 ~~a disruption in the classroom, on school grounds, in school vehicles, or~~
5 ~~at school activities or sanctioned events for a third time during a single~~
6 ~~school year or calendar year;~~

7 ~~(IV) Policies and procedures for the use of acts of reasonable and~~
8 ~~appropriate physical intervention or force in dealing with disruptive~~
9 ~~students; except that no board shall adopt a discipline code that includes~~
10 ~~provisions that are in conflict with the definition of child abuse in section~~
11 ~~18-6-401 (1), C.R.S., and section 19-1-103 (1), C.R.S.;~~

12 ~~(V) General policies and procedures for determining the~~
13 ~~circumstances under and the manner in which disciplinary actions,~~
14 ~~including suspension and expulsion, shall be imposed in accordance with~~
15 ~~the provisions of sections 22-33-105 and 22-33-106;~~

16 ~~(VI) A specific policy concerning gang-related activities in the~~
17 ~~school, on school grounds, in school vehicles, or at school activities or~~
18 ~~sanctioned events;~~

19 ~~(VII) Written prohibition, consistent with section 22-33-106, of~~
20 ~~students from bringing dangerous weapons, drugs, or other controlled~~
21 ~~substances to school, on school grounds, in school vehicles, or at school~~
22 ~~activities or sanctioned events and from using drugs, other controlled~~
23 ~~substances, or tobacco products on school grounds, in school vehicles, or~~
24 ~~at school activities or sanctioned events;~~

25 ~~(VIII) A written policy concerning searches on school grounds,~~
26 ~~including student lockers;~~

27 ~~(IX) A dress code policy that encourages school pride and unity;~~

1 promotes uniformity of dress, and defines and prohibits students from
2 wearing apparel that is deemed disruptive to the classroom environment
3 or to the maintenance of a safe and orderly school. The dress code policy
4 may require students to wear a school uniform or may establish minimum
5 standards of dress; and

6 ~~(X) (A) On and after August 8, 2001, a specific policy concerning~~
7 ~~bullying prevention and education. Each school district is encouraged to~~
8 ~~ensure that its policy, at a minimum, incorporates the biennial~~
9 ~~administration of surveys of students' impressions of the severity of~~
10 ~~bullying in their schools, as described in section 22-93-104 (1) (c);~~
11 ~~character building; and the designation of a team of persons at each~~
12 ~~school of the school district who advise the school administration~~
13 ~~concerning the severity and frequency of bullying incidents that occur in~~
14 ~~the school, which team may include, but need not be limited to, law~~
15 ~~enforcement officials, social workers, prosecutors, health professionals,~~
16 ~~mental health professionals, counselors, teachers, administrators, parents,~~
17 ~~and students. Each school district's policy shall set forth appropriate~~

22 ~~(B) For purposes of this subparagraph (X), "bullying" means any~~
23 ~~written or verbal expression, or physical or electronic act or gesture, or a~~
24 ~~pattern thereof, that is intended to coerce, intimidate, or cause any~~
25 ~~physical, mental, or emotional harm to any student. Bullying is prohibited~~
26 ~~against any student for any reason, including but not limited to any such~~
27 ~~behavior that is directed toward a student on the basis of his or her~~

1 ~~academic performance or against whom federal and state laws prohibit~~
2 ~~discrimination upon any of the bases described in section 22-32-109 (1)~~
3 ~~(II) (I). This definition is not intended to infringe upon any right~~
4 ~~guaranteed to any person by the first amendment to the United States~~
5 ~~constitution or to prevent the expression of any religious, political, or~~
6 ~~philosophical views.~~

7 (b) **Safe school reporting requirements.** A policy whereby the
8 principal of each public school ~~in~~ OF a school district shall submit
9 annually, in a manner and by a date specified by THE PROVISIONS OF
10 SECTION 22-32-146 AND BY rule of the state board, a written report to the
11 board of education of such school district concerning the learning
12 environment in the school during that school year. The board of education
13 of the school district annually shall compile the reports from every school
14 ~~in~~ OF the district and shall submit the compiled report to the department
15 of education in a format specified by rule of the state board. The compiled
16 report shall be made available to the general public. ~~Such report shall~~
17 ~~include, but need not be limited to, the following specific information for~~
18 ~~the preceding school year:~~

- 19 (I) ~~The total enrollment for the school;~~
20 (II) ~~The average daily attendance rate at the school;~~
21 (III) ~~Dropout rates for grades seven through twelve, if such grades~~

22 ~~threat of physical harm to the student or to other students;~~

12 ~~(C) Classroom removal in accordance with board policy;~~

6 (10) **Compliance with safe school reporting requirements.** If
7 the state board determines that a school district or one or more of the
8 public schools in a school district is in willful noncompliance with the
9 provisions of paragraph (b) of subsection (2) of this section OR OF
10 SECTION 22-32-146, the state's share of the school district's total program,
11 as determined pursuant to article 54 of this title, may be subject to
12 forfeiture until the school district and each school in the district attains
13 compliance with the provisions of paragraph (b) of subsection (2) of this
14 section.

15 **SECTION 3.** In Colorado Revised Statutes, **add** 22-32-145,
16 22-32-146, and 22-32-147 as follows:

17 **22-32-145. School conduct and discipline codes - training -**
18 **definitions.** (1) AS USED IN THIS SECTION, UNLESS THE CONTEXT
19 OTHERWISE REQUIRES:

20 (a) "BULLYING" MEANS ANY WRITTEN OR VERBAL EXPRESSION, OR
21 PHYSICAL OR ELECTRONIC ACT OR GESTURE, OR A PATTERN THEREOF, THAT
22 IS INTENDED TO COERCE, INTIMIDATE, OR CAUSE ANY PHYSICAL, MENTAL,
23 OR EMOTIONAL HARM TO ANY STUDENT. BULLYING IS PROHIBITED
24 AGAINST ANY STUDENT FOR ANY REASON, INCLUDING BUT NOT LIMITED TO
25 ANY SUCH BEHAVIOR THAT IS DIRECTED TOWARD A STUDENT ON THE BASIS
26 OF HIS OR HER ACADEMIC PERFORMANCE OR AGAINST WHOM FEDERAL AND
27 STATE LAWS PROHIBIT DISCRIMINATION UPON ANY OF THE BASES

1 DESCRIBED IN SECTION 22-32-109 (1) (II) (I). THIS DEFINITION IS NOT
2 INTENDED TO INFRINGE UPON ANY RIGHT GUARANTEED TO ANY PERSON BY

9 IN SECTION 22-33-102 (7).

10 (d) "HABITUALLY DISRUPTIVE STUDENT" SHALL HAVE THE SAME
11 MEANING AS SET FORTH IN SECTION 22-33-112 (1).

12 (e) "IN-SCHOOL SUSPENSION" SHALL HAVE THE SAME MEANING AS
13 SET FORTH IN SECTION 22-33-102 (10).

14 (f) "OUT-OF-SCHOOL SUSPENSION" SHALL HAVE THE SAME
15 MEANING AS SET FORTH IN SECTION 22-33-102 (12).

16 (g) "RESTORATIVE JUSTICE" SHALL HAVE THE SAME MEANING AS
17 SET FORTH IN SECTION 22-32-144 (3).

18 (h) "SCHOOL VEHICLE" SHALL HAVE THE SAME MEANING AS SET
19 FORTH IN SECTION 42-1-102 (88.5), C.R.S.

20 (i) "SUSPENSION" SHALL HAVE THE SAME MEANING AS SET FORTH
21 IN SECTION 22-33-102 (15).

22 (2) PURSUANT TO SECTION 22-32-109.1 (2) (a), EACH SCHOOL
23 DISTRICT BOARD OF EDUCATION SHALL INCLUDE WITHIN ITS SAFE SCHOOL
24 PLAN A CONDUCT AND DISCIPLINE CODE THAT SHALL INCLUDE, BUT NEED
25 NOT BE LIMITED TO:

26 (a) GENERAL POLICIES ON STUDENT CONDUCT, SAFETY, AND
27 WELFARE;

1 (b) GENERAL POLICIES AND PROCEDURES FOR DEALING WITH
2 STUDENTS WHO CAUSE A DISRUPTION IN THE CLASSROOM, ON SCHOOL
3 GROUNDS, IN A SCHOOL VEHICLE, OR AT A SCHOOL ACTIVITY OR
4 SANCTIONED EVENT, WHICH POLICIES AND PROCEDURES MAY INCLUDE A
5 SPECIFIC POLICY ALLOWING A TEACHER TO REMOVE A DISRUPTIVE
6 STUDENT FROM HIS OR HER CLASSROOM AND, UPON THE THIRD SUCH

17 provisions of part 1 of this article. Except as required by federal law, the
