The bill prohibits a dialysis treatment clinic from providing outpatient hemodialysis treatment to a non-end-stage renal disease patient without a referral for treatment from a board-certified or board-eligible nephrologist licensed as a physician in Colorado. It also eliminates the

existing requirement that home dialysis only be used in cases of end-stage renal disease.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 25-1.5-108, **amend**
3 (1) (a); and **add** (5.5) as follows:

5 **for hemodialysis technicians - state board of health rules - definitions**
6 **- repeal.** (1) As used in this section, unless the context otherwise
7 requires:

8 (a) "Dialysis treatment clinic" means a health facility or a
9 department or unit of a licensed hospital that is planned, organized,
10 operated, and maintained to provide outpatient hemodialysis treatment to,
11 or hemodialysis training for home use of hemodialysis equipment. ~~by,~~
12 ~~end-stage renal disease patients.~~

13 (5.5) A DIALYSIS TREATMENT CLINIC SHALL NOT PROVIDE
14 OUTPATIENT HEMODIALYSIS TREATMENT TO A NON-END-STAGE RENAL
15 DISEASE PATIENT WITHOUT A REFERRAL FOR TREATMENT FROM A
16 BOARD-CERTIFIED OR BOARD-ELIGIBLE NEPHROLOGIST LICENSED AS A
17 PHYSICIAN IN COLORADO. WHEN MAKING THE REFERRAL, THE
18 NEPHROLOGIST AND OTHER LICENSED PHYSICIANS WHO CARED FOR THE
19 PATIENT IN THE HOSPITAL SHALL USE THEIR PROFESSIONAL JUDGMENT TO
20 DETERMINE WHEN THE PATIENT NO LONGER REQUIRES HOSPITALIZATION
21 AND MAY RECEIVE OUTPATIENT DIALYSIS.

22 **SECTION 2. Safety clause.** The general assembly hereby finds,
23 determines, and declares that this act is necessary for the immediate
24 preservation of the public peace, health, and safety.
