**A BILL FOR AN ACT**

101     **CONCERNING THE METHOD OF NOTIFYING PEOPLE OF AMBER ALERTS**  
102             **TO PROMOTE THE LARGEST REACH OF COMMUNITY**

**Bill Summary**

Under current law, for an Amber alert, the Colorado bureau of investigation (CBI) sends notice to the federal communication's designated state emergency system broadcaster. Instead, the bill requires the CBI to send the alert using technological applications that promote the largest reach of community notifications.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2           **SECTION 1.** In Colorado Revised Statutes, 24-33.5-415.7,  
3 **amend** (3) introductory portion, (3)(c), and (3)(e) as follows:

4           **24-33.5-415.7. Amber alert program.** (3) The program shall  
5 MUST consist of the following:

6           (c) The BUREAU SHALL SEND THE alert ~~shall be sent to the federal~~  
7 ~~communications commission's designated state emergency alert system~~  
8 ~~broadcaster in Colorado~~ UTILIZING TECHNOLOGICAL APPLICATIONS THAT  
9 PROMOTE THE LARGEST REACH OF COMMUNITY NOTIFICATIONS.  
10 Participating radio and television stations shall issue the alert at  
11 designated intervals as specified in rule.

12           (e) The alert shall be cancelled upon bureau notification ~~to the~~  
13 ~~federal communications commission's designated state emergency alert~~  
14 ~~system broadcaster~~ that the child has been found or at the end of the  
15 notification period, whichever occurs first. WHEN APPLICABLE, THE  
16 BUREAU SHALL USE THE SAME TECHNOLOGICAL APPLICATIONS DESCRIBED  
17 IN SUBSECTION (3)(c) OF THIS SECTION. Any local law enforcement agency  
18 that locates a child who is the subject of an alert shall notify the bureau  
19 as soon as possible that the child has been located.

20           **SECTION 2. Safety clause.** The general assembly hereby finds,  
21 determines, and declares that this act is necessary for the immediate  
22 preservation of the public peace, health, or safety.
