Bill Summary

Joint Budget Committee. Currently the department of education is included in the definition of "state agency" as used in the office of information technology (office) provisions. The bill excludes the department of education from this definition.

Definitions.** As used in this article 37.5, unless the 5 context otherwise requires: 6 (4) "State agency" means all of the departments, divisions, 7 commissions, boards, bureaus, and institutions in the executive branch of the state government. "State agency" does not include the legislative or 8 9 judicial department, THE DEPARTMENT OF EDUCATION, the department of 10 law, the department of state, the department of the treasury, or 11 state-supported institutions of higher education. 12 **SECTION 2.** In Colorado Revised Statutes, 24-37.5-106, amend 13 (1.7) as follows: Chief information officer - duties and 14 24-37.5-106. 15 responsibilities - broadband inventory fund created. (1.7) The chief 16 information officer may enter into contracts with any local government, 17 state agency, or political subdivision of the state, including the legislative 18 and judicial departments, THE DEPARTMENT OF EDUCATION, the 19 department of law, the department of state, the department of treasury, or 20 state-supported institutions of higher education, for the purpose of 21 providing disaster recovery services. SECTION 3. Act subject to petition - effective date. This act 22 23 takes effect at 12:01 a.m. on the day following the expiration of the 24 ninety-day period after final adjournment of the general assembly (August

2, 2019, if adjournment sine die is on May 3, 2019); except that, if a referendum petition is filed pursuant to section 1 (3) of article V of the state constitution against this act or an item, section, or part of this act within such period, then the act, item, section, or part will not take effect unless approved by the people at the general election to be held in November 2020 and, in such case, will take effect on the date of the

official declaration of the vote thereon by the governor.
