## AN ACT CONCERNING THE ONLINE SALE AND DELIVERY OF ELECTRONIC NICOTINE DELIVERY SYSTEMS AND VAPOR PRODUCTS.

Be it enacted by the Senate and House of Representatives in General Assembly convened:

- 1 Section 1. (NEW) (Effective July 1, 2019) (a) As used in this section, 2 "electronic nicotine delivery systems" and "vapor products" have the
- 3 same meanings as provided in section 19a-342a of the general statutes.
- 4 (b) Any person who sells electronic nicotine delivery systems or vapor products online and ships electronic nicotine delivery systems or vapor products directly to a consumer in this state shall: (1) Require such consumer to provide a copy of such consumer's valid motor vehicle operator's license or a valid identity card, as described in section 1-1h of the general statutes, at purchase; (2) ensure that the name on such motor vehicle operator's license or identity card is identical to the name on the credit card, charge card, debit card or other method of payment used to purchase such electronic nicotine delivery systems or vapor products; (3) ensure that the shipping labels 14 on all packages containing such electronic nicotine delivery systems or

vapor products conspicuously state the following: "CONTAINS

- 16 ELECTRONIC NICOTINE DELIVERY SYSTEMS OR VAPOR
- 17 PRODUCTS SIGNATURE OF A PERSON AGE 18 OR OLDER
- 18 REQUIRED FOR DELIVERY"; and (4) obtain the signature of a person
- 19 age eighteen or older at the address prior to delivery, after requiring
- 20 the signer to demonstrate that the signer is age eighteen or older by
- 21 providing a valid motor vehicle operator's license or valid identity
- 22 card.
