AN ACT CONCERNING THE PUBLICATION OF LEGAL NOTICES BY MUNICIPALITIES.

Be it enacted by the Senate and House of Representatives in General Assembly convened:

- 1 Section 1. (NEW) (Effective October 1, 2019) (a) Whenever any town,
- 2 city, borough, district, board, commission or other agency is required
- 3 to publish a legal notice in a newspaper pursuant to any provision of
- 4 section 7-3, 7-9c, 7-85, 7-131j, 7-131n, 7-139, 7-147b, 7-147q, 7-163e, 7-
- 5 191, 7-222, 7-247a, 7-250, 7-252, 7-255, 7-263a, 7-273f, 7-273g, 7-325, 7-
- 6 327, 7-344, 7-485, 7-492, 7-601, 8-2j, 8-3, 8-3c, 8-7, 8-7d, 8-23, 8-26e, 8-28,
- 7 8-29, 8-35a, 8-44, 8-127, 8-127a, 8-129, 8-169d, 8-169s, 8-169v, 8-189, 8-
- 8 191, 8-294 or 22-332 of the general statutes, such town, city, borough,
- 9 district, board, commission or other agency may elect to publish a brief
- 10 legal notice pursuant to subsection (b) of this section in lieu of the
- 11 notice required in any of said sections, provided such town, city,
- borough, district, board, commission or other agency complies with all
- 13 other requirements under the provisions of said sections concerning
- 14 the timing and frequency of such publication.
- 15 (b) Any such brief legal notice shall include, but not be limited to,

16 (1) a description of the subject matter being noticed; (2) (A) the date, 17 time and location if the subject matter is a meeting or public hearing, 18 (B) the hours during which polls will be open if the subject matter is a 19 referendum or election, (C) the address or other description if the 20 subject matter concerns real property, and (D) the decision or other 21 action taken if the subject matter concerns an application; (3) the 22 Internet web site address at which additional information concerning 23 the subject matter is available; (4) the physical address and office hours 24 of the office of the town clerk, at which additional information 25 concerning the subject matter shall be made available for public 26 inspection; and (5) a telephone number that may be called to request 27 that a copy of additional information concerning the subject matter be 28 mailed at no charge. As used in this section, "additional information" 29 includes any information otherwise required to be published in a legal 30 notice pursuant to the sections referenced in subsection (a) of this 31 section.

Sec. 2. (NEW) (*Effective October 1, 2019*) Each newspaper that publishes any legal notice for any municipality shall indicate, in the index of such newspaper, each page on which any such legal notice is printed.

This act shall take effect as follows and shall amend the following sections:

To authorize municipalities to publish shorter legal notices in the newspaper if additional information is made available to the public by other means, and to require any newspaper that publishes legal notices for municipalities to indicate in the index of the newspaper the page on which such legal notices may be found.
