## AN ACT REVISING CERTAIN ABSENTEE VOTING STATUTES.

Be it enacted by the Senate and House of Representatives in General Assembly convened:

- Section 1. Section 9-135 of the general statutes is repealed and the following is substituted in lieu thereof (*Effective October 1, 2019*):
- 3 (a) Any elector eligible to vote at a primary or an election and any person eligible to vote at a referendum may vote by absentee ballot if 4 5 he or she is unable to appear at his or her polling place [during the 6 hours of voting] on the day of such primary, election or referendum 7 for any of the following reasons: (1) His or her active service with the 8 armed forces of the United States; (2) his or her absence from the town 9 of [his or her voting residence during all of the hours of voting] which 10 he or she is an inhabitant; (3) his or her [illness] sickness; (4) his or her 11 physical disability; (5) the tenets of his or her religion forbid secular 12 activity; [on the day of the primary, election or referendum;] or (6) the 13 required performance of his or her duties as a primary, election or 14 referendum official, including as a town clerk or registrar of voters or 15 as staff of the clerk or registrar, at a polling place other than his or her 16 own during all of the hours of voting at such primary, election or

- 17 referendum.
- 18 (b) No person shall misrepresent the eligibility requirements for
- 19 voting by absentee ballot prescribed in subsection (a) of this section, to
- any elector or prospective absentee ballot applicant.
- 21 Sec. 2. Section 9-137 of the general statutes is repealed and the
- following is substituted in lieu thereof (*Effective October 1, 2019*):
- Each absentee ballot shall be returned to the municipal clerk,
- 24 inserted in an inner envelope which shall be capable of being sealed
- 25 and which shall have printed on its face a form containing the
- 26 following statements:
- 27 "I hereby state under the penalties of false statement in absentee
- 28 balloting that I am eligible to vote at the primary, election or
- 29 referendum in the municipality in which this absentee ballot is to be
- 30 cast and that I expect to be unable to appear at my polling place
- 31 [during the hours of voting at] on the day of such primary, election or
- 32 referendum for one or more of the following reasons: (1) My active
- 33 service in the armed forces; (2) my absence from the town in which I
- 34 am eligible to vote; [during all of the hours of voting;] (3) my [illness]
- 35 sickness or physical disability; (4) the tenets of my religion which
- 36 forbid secular activity; [on the day of the primary, election or
- 37 referendum;] or (5) my duties as a primary, election or referendum
- 38 official.
