Enclosed for consideration and approval by the Council of the District of Columbia is proposed emergency legislation, "Contract Number DCHT-2012-C-0016 and Modification Nos. M0001, M0002, M0003 and M0004 to Contract Number DCHT-2012-C-0016 Approval and Payment Authorization Emergency Act of 2013" and the corresponding declaration resolution to approve Contract Number DCHT-2012-C-0016 and Modification Nos. M0001, M0002, M0003 and M0004 to Contract Number DCHT-2012-C-0016 with Medical Transportation Management, Inc. to manage and administer the District's non-emergency transportation services program for the District's Medicaid eligible fee-for service recipients. Approval is necessary to allow the District to continue to receive the benefit of these vital services from this vendor.

Council action is necessary to approve anticipated contract payments in the total of \$11,474,704.00 for the period from August 31, 2012 to March 14, 2013.

The agency Chief Financial Officer has certified that funding is available for FY 2012.

20 To declare the existence of an emergency with respect to the need to approve Contract  
21 Number DCHT-2012-C-0016 and Modification Nos. M0001, M0002, M0003 and  
22 M0004 to Contract Number DCHT-2012-C-0016 to manage and administer the  
23 District's non-emergency transportation services program for the District's  
24 Medicaid eligible fee-for service recipients and to authorize payment for the  
25 services received and to be received under the contract

27 RESOLVED, BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That

28 this resolution may be cited as the "Contract Number DCHT-2012-C-0016 and  
29 Modification Nos. M0001, M0002, M0003 and M0004 to Contract Number DCHT-2012-  
30 C-0016 Approval and Payment Authorization Emergency Declaration Resolution of  
31 2013".

32 Sec. 2. (a) There exists an immediate need to approve Contract Number DCHT-  
33 2012-C-0016 and Modification Nos. M0001, M0002, M0003 and M0004 to Contract  
34 Number DCHT-2012-C-0016 and to authorize payment for the services received and to  
35 be received under the contract.

1 (b) The District originally entered into a contract DCHC-2007-E-0001 with  
2 Medical Transportation Management, Inc. (MTM) to provide non-emergency  
3 transportation services program for the District's Medicaid eligible fee-for service  
4 recipients from July 20, 2007, through July 19, 2008, with four one year options.

5 (c) Upon expiration of the final option period Emergency Contract DCHT-2012-  
6 C-0016 was awarded to MTM on August 31, 2012 through December 29, 2012 in the  
7 amount of \$6,370,988.00.

8 (d) Modification No. M0001 extended Emergency Contract DCHT-2012-C-0016  
9 for the period of December 30, 2012 to January 12, 2013 for a total of \$893,723.00.

10 (e) Modification No. M0002 extended Emergency Contract DCHT-2012-C-0016  
11 for the period of January 13, 2013 to January 31, 2013 for a total of \$1,212,910.00.

12 (f) Modification No. M0003 extended Emergency Contract DCHT-2012-C-0016  
13 for the period of February 1, 2013 to February 28, 2013 for a total of \$2,103,360.00.

14 (g) Modification No. M0004 extended Emergency Contract DCHT-2012-C-0016  
15 for the period of March 1, 2013 to March 14, 2013 for a total of \$893,723.00.

16 (h) Council approval is necessary because the value of Contract Number DCHT-  
17 2012-C-0016 and Modification Nos. M0001, M0002, M0003 and M0004 to Contract  
18 Number DCHT-2012-C-0016 are more than \$1,000,000.00 during a 12-month period.

19 (i) Approval is necessary to allow the continuation of these vital services.  
20 Without this approval, MTM cannot be paid for services provided in excess of  
21 \$1,000,000.00.

22 Sec. 3. The Council determines that the circumstances enumerated in section 2  
23 constitute emergency circumstances making it necessary that Contract Number DCHT-

1 2012-C-0016 and Modification Nos. M0001, M0002, M0003 and M0004 to Contract  
2 Number DCHT-2012-C-0016 Approval and Payment Authorization Emergency Act of  
3 2013 be adopted after a single reading.

4           Sec. 4. This resolution shall take effect immediately.
