9 10	To authorize the Mayor to solicit advertisements and sponsorships to generate revenue for the

15	BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this
16	act may be cited as the "Turkey Bowl Revenue Generation and Sponsorship Act of 2014".
17	Sec. 2. (a) Notwithstanding any other provision of law, the Mayor may enter into one or
18	more written agreements for advertisements and sponsorships to supplement local funding for
19	the annual District of Columbia Interscholastic Athletic Association ("DCIAA") Championship
20	Turkey Bowl and other DCIAA athletic activities and programs. The Mayor may delegate this
21	authority to the Chancellor of the District of Columbia Public Schools ("DCPS").
22	(b) The Chancellor of DCPS may sub-delegate, by written order, the authority to contract
23	for advertisements or sponsorships to another official within DCPS.
24	(c) An agreement pursuant to this act shall not require the District to expend funds.
25	(d) Only advertisements shall be agreed to in exchange for corporate goods, services, or
26	funds.
27	(e) There shall be no limit to the value of goods, services, or funds that may be received
28	from an organization, registered or not, or from an individual, regardless of whether the
29	organization is located, or individual resides, within the District of Columbia.

30	(f) Any sponsorship or advertisement pursuant to this act shall be memorialized by
31	written agreement of the parties.
32	(g) The Chief Financial Officer shall deposit all cash proceeds received from
33	advertisements and sponsorships pursuant to this act to the credit of the District of Columbia
34	Public Schools in the same manner as that used for donations under section 115 of the District of
35	Columbia Appropriations Act, 2003, approved February, 2003 (117 Stat. 123; D.C. Official
36	Code § 1-329.01).
37	(h) The Chancellor of DCPS shall keep an accounting of all goods, services, and funds
38	received pursuant to this act.

44	This act shall take effect following approval by the Mayor (or in the event of veto by the

47	24, 1973 (87 Stat. 813: D.C. Official Code § 1-206.02(c)(1)), and publication in the District of
48	Columbia Register.
