21	(b) A new section 47-1099.02 is added to read as follows:
22	"§ 47-1099.02. University of the District of Columbia, Lot 114, Square 676.
23	"The real property located at 801 North Capitol Street, N.E., Washington, D.C., and
24	described as Lot 114, Square 676, shall be exempt from real property taxation so long as the real
25	property continues to be leased by the University of the District of Columbia.".

12	This act shall take effect following approval by the Mayor (or in the event of veto by the
13	Mayor, action by the Council to override the veto), a 30-day period of Congressional review as
14	provided in section 602(c)(2) of the District of Columbia Home Rule Act, approved December
15	24, 1973 (87 Stat. 813; D.C. Official Code § 1-206.02(c)(2)), and publication in the District of
16	Columbia Register.
