Dear Chairman Mendelson:

Enclosed for consideration and approval by the Council of the District of Columbia is proposed emergency act, the "Contract No. CW60505 with First Vehicle Services, Inc. Approval and Payment Authorization Emergency Act of 2018", to approve multiyear Contract No. CW60505 to provide maintenance services for the District of Columbia Metropolitan Police Department vehicle fleet. Approval is necessary to allow the District to continue to receive the benefit of these vital goods and services without interruption, and the critical requirements of the District can only be met through an award of the multiyear contract.

Council approval is required by section 451(c)(3) of the District of Columbia Home Rule Act, approved December 24, 1973, 87 Stat. 803, Pub. L. 93-198; D.C. Official Code § 1-204.51(c)(3).

A letter contract in the not-to-exceed amount of \$992,235.00 was executed on September 30, 2018 with an effective date of October 1, 2018. The term of contract will be from October 1, 2018 through September 30, 2021 at a not-to-exceed amount of \$21,729,947.12. The Chief Financial Officer for the District Metropolitan Police Department has certified that funding is available for FY 2019.



IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

To approve, on an emergency basis, a multiyear contract, Contract No. CW60506 with First Vehicle Services, Inc. to provide maintenance services for the District of Columbia Metropolitan Police Department vehicle fleet and to authorize payment for the goods and services received and to be received under the contract.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the " Contract No. CW60505 with First Vehicle, Inc. Approval and Payment Authorization Emergency Act of 2018".

Sec. 2. Pursuant to section 451 of the District of Columbia Home Rule Act, approved December 24, 1973 (87 Stat. 803; D.C. Official Code § 1-205.51), and notwithstanding the requirements of section 105a of the District of Columbia Procurement Practices Act of 1985, effective March 8, 1991 (D.C. Law 8-257; D.C. Official Code § 2-301.05a), the Council approves a multiyear contract, Contract No. CW60506 with First Vehicle Services, Inc. to provide maintenance services for the District of Columbia Metropolitan Police Department vehicle fleet and authorizes payment in the not-to-exceed amount of \$21,729,947.12 for goods and services received and to be received under the contract.

42 section 412(a) of the District of Columbia Home Rule Act, approved December 24, 1973 (87
43 Stat. 788; D.C. Official Code § 1-204.12(a)).
