Dear Chairman Mendelson:

Today, I am transmitting to the Council of the District of Columbia for its consideration and enactment the "District of Champions Extension of Hours Amendment Act of 2020." The proposed bill would amend D.C. Official Code § 25-723 to authorize the Alcoholic Beverage Control Board (ABC Board) to allow on-premises retailers or manufacturers holding an on-site sales and consumption permit who are registered with ABRA's extended hours program, and temporary license holders to sell, serve, and allow the consumption of alcoholic beverages until 4 a.m. and to operate 24 hours a day on those days a District of Columbia professional sports team is playing in a postseason game.

In the past, the Council has allowed licensed establishments to operate and sell, serve, and allow the consumption of alcoholic beverages for extended periods for sporting events. Most recently in 2018, the Council passed legislation to allow for extended hours at licensed establishments during the World Cup and the 2018 All-Star Game.

Sporting events, particularly postseason games, create a lot of excitement in the District. Over the last few years, District residents have enjoyed the successes of our professional sports teams. Thousands of people living or visiting the District of Columbia have joined to celebrate when our beloved teams were in the playoffs and finals. This bill would capitalize on this excitement by allowing the ABC Board to extend the hours of operations, sales, service, and consumption of alcoholic beverages during the postseason for those licensed establishments that are registered to participate in the extended hours program.

Unless an exception applies, a holder of an on-premise retailer license or temporary license, or a manufacturer possessing an on-site sales and consumption permit may only operate, sell, serve, and allow for the consumption of alcoholic beverages on any day and any time except for between 2:00 a.m. to 8:00 a.m., Monday through Friday, and between 3:00 a.m. and 8:00 a.m., Saturday and Sunday, excluding District and Federal holidays. *See* D.C. Official Code § 25-723(a).

The proposed bill would amend D.C. Official Code § 25-723 by adding a new subsection (g) which would provide the Board with the authority to allow on-premises retailer licensees or manufacturers holding an on-site sales and consumption permit, and temporary licensees to operate 24-hours a day and sell alcoholic beverages until 4:00 a.m., on those days in which a District of Columbia professional sports team is playing in the postseason.

I urge the Council to take prompt and favorable action on the enclosed legislation.

Conclusion

Funds are sufficient in the fiscal year 2020 through fiscal year 2023 budget and financial plan to implement the bill.

Background

The Alcoholic Beverage Control Board (Board) allows licensed establishments holding on-site sales and consumption permits to serve alcohol for extended hours on various holidays and during inauguration week. The exceptions granted by the Board allow establishments to sell beverages until 4:00 a.m. and to operate for 24-hours. 1 The Board must pre-approve licensees to participate in these extended hours opportunities. The Board also approves one-time exceptions for extended hours outside of these prescribed occasions, when appropriate.

The bill establishes an additional exception to allow extended sales and operating hours when any District professional sports team is participating in a postseason game or match. The exception is available to pre-approved licensees.2 The exception applies to playoff games or matches played by professional soccer, tennis, hockey, baseball, football, or basketball teams. The bill requires the Board

to notify the Metropolitan Police Department (MPD) at least 48 hours prior to the extended hours taking effect and include the list of participating licensees.

Financial Plan Impact

Funds are sufficient in the fiscal year 2020 through fiscal year 2023 budget and financial plan to implement the bill. The Board has approved one-time extended hours exceptions for playoff sporting events in the past. A broader exemption for future playoff games will ease the administrative burden at the Board and the Alcoholic Beverage Regulation Administration (ABRA) to approve one-time exceptions during playoff games. The Board and ABRA have a night-time enforcement staff that can absorb the enforcement activities associated with this additional exception. The Board must notify MPD when establishments will operate under extended hours, but there are no additional activities required of MPD.
