WHEREAS, Susan Vener Linsky helped further the economic development and philanthropic environment of Washington, D.C. at the D.C. Chamber of Commerce and Greater D.C. Cares;

WHEREAS, Susan Vener Linsky has been an outstanding community member volunteering to make the city a better place in her service to Murch Elementary School, as the HSA President of the School Without Walls, as Vice President of the Avalon Theater Board of
