## IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

# April 2, 2019

To declare the existence of an emergency with respect to the need to approve Modification Nos. 25, 26, 27, and 28 to Contract No. CW18948 with Aramark Correctional Services, LLC to provide management and operation of the food service program for inmates, and to authorize payment for the goods and services received and to be received under the modifications.

RESOLVED, BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this resolution may be cited as the "Modifications to Contract No. CW18948 Approval and Payment Authorization Emergency Declaration Resolution of 2019".

- Sec. 2. (a) There exists a need to approve Modification Nos. 25, 26, 27, and 28 to Contract No. CW18948 with Aramark Correctional Services, LLC to provide management and operation of the food service program for inmates, and to authorize payment for the goods and services received and to be received under the modifications.
- (b) On September 29, 2018, the Council approved the Sole Source Extension for Contract No. CW18948 with Aramark Correctional Services, LLC (CA 22-0643) for the period from October 1, 2018, through December 31, 2018.
- (c) By Modification No. 25, the Office of Contracting and Procurement ("OCP"), on behalf of the Department of Corrections ("DOC"), increased the amount of Contract No. CW18948 by \$641,306.40 for the period from January 1, 2019, through February 28, 2019.
- (d) By Modification No. 26, OCP, on behalf of DOC, further increased the amount of Contract No. CW18948 by \$347,048.10 for the period from March 1, 2019, through March 31, 2019.
- (e) By Modification No. 27, OCP, on behalf of DOC, further increased the amount of Contract No. CW18948 by \$156,731.40 for the period from April 1, 2019, through April 14, 2019.
- (f) Modification No. 28 is now necessary to increase the amount of Contract No. CW18948 by \$1,712,850.30 for the period from April 15, 2019, through September 14, 2019, raising the total contract amount by \$2,857,936.20.

#### **ENROLLED ORIGINAL**

- (g) Council approval is required by section 451(b) of the District of Columbia Home Rule Act, approved December 24, 1973 (87 Stat. 803; D.C. Official Code § 1-204.51(b)), because these modifications increase the contract by more than \$1 million during a 12-month period.
- (h) Approval is necessary to allow the continuation of these vital services. Without this approval, Aramark Correctional Services, LLC cannot be paid for goods and services provided in excess of \$1 million for the period from January 1, 2019, through September 14, 2019.
- Sec. 3. The Council of the District of Columbia determines that the circumstances enumerated in section 2 constitute emergency circumstances making it necessary that the Modifications to Contract No. CW18948 Approval and Payment Authorization Emergency Act of 2019 be adopted after a single reading.
  - Sec. 4. This resolution shall take effect immediately.
