Biography



Acting Executive Director Heran Sereke-Brhan has been Senior Grants Officer for CAH since July 2017. Prior to joining CAH, she served as Deputy Director for the Mayor’s Office on African Affairs. Heran has spent over two decades studying and conducting research on African histories and cultures. Having grown up enjoying music and theatre performances in Addis Ababa, Ethiopia, where many of the artists were personal friends of her family, Heran understood how the arts nurtured the imagination and created community connection. As a way of giving back, Heran later compiled and edited several works of such notable Ethiopian artists as playwright and national poet laureate Tsegaye Gebre-Medhin, painter-poet Gebre-Kristos Desta, and poet and art critic Solomon Deresa, thereby preserving and transmitting their works for posterity.

While a graduate student, she was a founding member of inter-disciplinary and performance groups *Monumental Discoveries*, *Mwendo Black Theatre and Creative Arts Group* and *Amka Africa*. Heran has contributed towards a number of film projects and served as host for a weekly radio program on WDBM in East Lansing, Michigan. As an academic, she has explored aspects of social and political history and the role of women in 19th and 20th century Ethiopia, as well as topics in art history and intellectual property issues for Africa.

In her role as Academic Director following graduate school, Heran successfully integrated traditional and contemporary arts and humanities into a semester-long study abroad program for the School for International Training. She has worked at a number of cultural and educational institutions, including the Harn Museum at the University of Florida, Addis Ababa University, and the Smithsonian’s National Museum of African Art.

Heran holds a PhD in History with minors in African American and Caribbean History and African Art History from Michigan State University.
