# IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

#### February 7, 2023

To declare the existence of an emergency with respect to the need to approve multiyear Contract No. CW95508 with Johnson, Mirmiran & Thompson, Inc. to provide design build services to advance the environmental assessment and preliminary designs for the Oxon Run Stream and Wetland Restoration Project, and to authorize payment for the goods and services received and to be received under the contract.

RESOLVED, BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this resolution may be cited as the "Contract No. CW95508 with Johnson, Mirmiran & Thompson, Inc. Approval and Payment Authorization Emergency Declaration Resolution of 2023".

Sec. 2. (a) There exists an immediate need to approve Contract No. CW95508 with Johnson, Mirmiran & Thompson, Inc. to provide design build services to advance the environmental assessment and preliminary designs for the Oxon Run Stream and Wetland Restoration Project and to authorize payment for the goods and services received and to be received under the contract.

(b) By letter contract dated February 24, 2022, the Office of Contracting and Procurement, on behalf of the Department of Energy and Environment, awarded Contract No. CW95508 to Johnson, Mirmiran & Thompson, Inc. in the not-to-exceed amount of \$744,334.48 for the period February 24, 2022, through June 24, 2022.

(c) Modification No. 1 extended the period of performance through October 24, 2022, at no additional cost.

(d) Modification No. 2 added \$238,415.42 to the letter contract.

(e) Modification No. 3 extended the period of performance through November 24, 2022, at no additional cost.

(f) Modification No. 4 extended the period of performance through December 24, 2022, at no additional cost.

(g) Modification No. 5 extended the period of performance through January 24, 2023, at no additional cost.

(h) Modification No. 6 extended the period of performance through February 23, 2023, at no additional cost.

### **ENROLLED ORIGINAL**

(i) Proposed Modification No. 7 is now necessary to increase the not-to-exceed price for the term of this multiyear contract with Johnson, Mirmiran & Thompson, Inc. to \$2,615,600.48 for the period from February 24, 2022, through February 23, 2025.

(j) Approval is necessary to allow the District to continue to receive the benefit of these vital services in a timely manner from Johnson, Mirmiran & Thompson, Inc.

(k) These critical design build services can only be obtained through an award of the multiyear contract with Johnson, Mirmiran & Thompson, Inc.

Sec 3. The Council of the District of Columbia determines that the circumstances enumerated in section 2 constitute emergency circumstances making it necessary that the Contract No. CW95508 with Johnson, Mirmiran & Thompson, Inc. Approval and Payment Authorization Emergency Act of 2023 be adopted after a single reading.

Sec. 4. This resolution shall take effect immediately.
