

A RESOLUTION

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

April 4, 2023

To declare the existence of an emergency with respect to the need to approve Modification Nos. 1, 2, and 3 to Contract No. CW94739 with Ramsell Corporation to provide a secure, web-accessible platform that integrates core AIDS Drug Assistance Program pharmacy benefit managers, 340B inventory management, and insurance premium and co-pay management for both the AIDS Drug Assistance and the District-funded pre-exposure prophylaxis medication assistance programs, and to authorize payment for the goods and services received and to be received under the contract.

RESOLVED, BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this resolution may be cited as the “Modifications to Contract No. CW94739 with Ramsell Corporation Approval and Payment Authorization Emergency Declaration Resolution of 2023”.

Sec. 2. (a) There exists an immediate need to approve Modification Nos. 1, 2, and 3 to Contract No. CW94739 with Ramsell Corporation to provide to provide a secure, web-accessible platform that integrates core AIDS Drug Assistance Program (“ADAP”) pharmacy benefit managers, 340B inventory management, and insurance premium and co-pay management for both ADAP and the District-funded pre-exposure prophylaxis medication assistance program and to authorize payment for the goods and services received and to be received under the contract.

(b) By Modification No. 1, dated January 18, 2023, the Office of Contracting and Procurement (“OCP”), on behalf of the Department of Health (“DOH”), partially exercised option year one for the period January 18, 2023 through March 31, 2023, in the not-to-exceed amount of \$999,000.

(c) By Modification No. 2, dated February 21, 2023, OCP, on behalf of DOH, exercised another partial option of option year one for the period April 1, 2023 through April 4, 2023, at no cost to the District.

(d) Modification No. 3 is now necessary to exercise the remainder of option year one in the not-to-exceed amount of \$6,531,851.32, bringing the total not-to-exceed amount for the period from January 18, 2023 through January 17, 2024, to \$7,530,851.32.

(e) Council approval is necessary because these modifications increase the contract to more than \$1 million during a 12-month period.

(f) Council approval is necessary to allow the continuation of these vital services. Without this approval, Ramsell Corporation cannot be paid for goods and services provided in excess of \$1 million.

Sec. 3. The Council determines that the circumstances enumerated in section 2 constitute emergency circumstances making it necessary that the Modifications to Contract No. CW94739 with Ramsell Corporation Approval and Payment Authorization Emergency Act of 2023 be adopted after a single reading.

Sec. 4. This resolution shall take effect immediately.
