

RESOLVED, BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this resolution may be cited as the "District of Columbia Judicial Disabilities and Tenure Commission Dr. Patrick Jackson Appointment Resolution of 2023". Sec. 2. The Council of the District of Columbia appoints: Dr. Patrick Jackson Reservoir Road NW Washington, DC 20007 (Ward 3) as a nonlawyer member of the District of Columbia Judicial Disabilities and Tenure Commission, established by section 431(d) of the District of Columbia Home Rule Act, approved December 24, 1973 (87 Stat. 792; D.C. Official Code § 1-204.31(d)), for a term to end May 5, 2028. Sec. 3. The Council of the District of Columbia shall transmit a copy of this resolution, upon its adoption, to the appointee, to the chairperson of the Commission on Judicial Disabilities and Tenure, and to the Office of the Mayor.
