The Honorable Adam R. Hunter has extensive experience as a litigator in Washington, DC. Prior to Judge Hunter's appointment previous appointment to the Rental Housing Commission, he was a founding partner of Hunter & Johnson, PLLC, a boutique litigation firm based in Washington, DC. His litigation experience included representing both landlords and tenants in Superior Court and before the Office of Administrative Hearings, civil litigation, and criminal defense. Part of his practice was dedicated to representing District of Columbia residents in

criminal cases through the Criminal Justice Act.

Prior to forming Hunter & Johnson, PLLC, Judge Hunter was Of Counsel with Harden & Pinckney, PLLC in the District of Columbia with a primary focus on criminal defense and civil litigation. He clerked for the Honorable Lorraine Pullen (Ret.) in Middlesex County Superior Court Criminal Division in New Jersey.
