A bill to be entitled An act relating to the Department of Highway Safety and Motor Vehicles; amending s. 318.1215, F.S.; revising the amount of a fee that a clerk of court may be required to collect with each civil traffic penalty; amending s. 320.02, F.S.; providing exceptions to a requirement that the owner of a motor vehicle notify the department of a change of address within a specified time period; revising such time period; amending ss. 322.051 and 322.21, F.S.; providing for the issuance of identification cards at no charge to certain persons in the custody or under the supervision of the Department of Juvenile Justice; requiring certain identification cards to be processed by the Department of Highway Safety and Motor Vehicles' mobile issuing units; amending s. 322.19, F.S.; providing exceptions to a requirement that a person obtain a replacement driver license reflecting a change of name within a specified time period; revising the time period for obtaining a replacement license reflecting certain changes of information; requiring certain persons to obtain a replacement identification card reflecting a change of name within a specified time period; amending s. 322.221, F.S.; directing the department to issue an identification card at no cost to a person whose driver license is

Be It Enacted by the Legislature of the State of Florida:

Section 1. Section 318.1215, Florida Statutes, is amended to read:

Notwithstanding the provisions of s. 318.121, a board of county commissioners may require, by ordinance, that the clerk of the court collect an additional \$7 \\$5 with each civil traffic penalty, which shall be used to fund driver education programs in public and nonpublic schools. The ordinance shall provide for the board of county commissioners to administer the funds, which shall be used for enhancement, and not replacement, of driver education program funds. The funds shall be used for direct educational expenses and shall not be used for administration. Each driver education program receiving funds pursuant to this section shall require that a minimum of 30 percent of a student's time in the program be behind-the-wheel training. This section may be cited as the "Dori Slosberg Driver Education

320.02 Registration required; application for registration; forms.—

- (4) Except for a person subject to s. 775.21, s. 775.261, s. 943.0435, s. 944.607, or s. 985.4815, the owner of any motor vehicle registered in the state shall notify the department in writing of any change of address within 30 20 days after of such change. The notification shall include the registration license plate number, the vehicle identification number (VIN) or title certificate number, year of vehicle make, and the owner's full name.
- Section 3. Subsection (9) of section 322.051, Florida Statutes, is amended to read:

322.051 Identification cards.-

(9) Notwithstanding any other provision of this section or s. 322.21 to the contrary, the department shall issue or renew a card at no charge to a person who presents evidence satisfactory to the department that he or she is homeless as defined in s. 414.0252(7), to a juvenile offender who is in the custody or under the supervision of the Department of Juvenile Justice and receiving services pursuant to s. 985.461, to an inmate receiving a card issued pursuant to s. 944.605(7), or, if necessary, to an inmate receiving a replacement card if the department determines that he or she has a valid state identification card. If the replacement state identification card is scheduled to expire within 6 months, the department may

also issue a temporary permit valid for at least 6 months after the release date. The department's mobile issuing units shall process the identification cards for juvenile offenders and inmates at no charge, as provided by s. 944.605(7)(a) and (b).

Section 4. Subsections (1) and (2) of section 322.19, Florida Statutes, are amended to read:

322.19 Change of address or name.

- (1) Except as provided in s. 775.21, s. 775.261, s. 943.0435, s. 944.607, or s. 985.4815, whenever any person, after applying for or receiving a driver license or identification card, changes his or her legal name, that person must within 30 days thereafter obtain a replacement license or card that reflects the change.
- (2) If a Whenever any person, after applying for or receiving a driver license or identification card, changes the legal residence or mailing address in the application, or license, or card, the person must, within 30 10 calendar days after making the change, obtain a replacement license or card that reflects the change. A written request to the department must include the old and new addresses and the driver license or identification card number. Any person who has a valid, current student identification card issued by an educational institution in this state is presumed not to have changed his or her legal residence or mailing address. This subsection does not affect any person required to register a permanent or temporary address change pursuant to s. 775.13, s. 775.21, s. 775.25, or s.

- Section 5. Paragraph (f) of subsection (1) of section
- 107 322.21, Florida Statutes, is amended to read:
- 322.21 License fees; procedure for handling and collecting fees.—
  - (1) Except as otherwise provided herein, the fee for:
  - (f) An original, renewal, or replacement identification card issued pursuant to s. 322.051 is \$25, except that an applicant who presents evidence satisfactory to the department that he or she is homeless as defined in s. 414.0252(7); or his or her annual income is at or below 100 percent of the federal poverty level; or he or she is a juvenile offender who is in the custody or under the supervision of the Department of Juvenile Justice, is receiving services pursuant to s. 985.461, and whose identification card is issued by any of the department's mobile issuing units is exempt from such fee. Funds collected from fees for original, renewal, or replacement identification cards shall be distributed as follows:
  - 1. For an original identification card issued pursuant to  $s.\ 322.051$ , the fee shall be deposited into the General Revenue Fund.
  - 2. For a renewal identification card issued pursuant to s. 322.051, \$6 shall be deposited into the Highway Safety Operating Trust Fund, and \$19 shall be deposited into the General Revenue Fund.
    - 3. For a replacement identification card issued pursuant

to s. 322.051, \$9 shall be deposited into the Highway Safety Operating Trust Fund, and \$16 shall be deposited into the General Revenue Fund. Beginning July 1, 2015, or upon completion of the transition of the driver license issuance services, if the replacement identification card is issued by the tax collector, the tax collector shall retain the \$9 that would otherwise be deposited into the Highway Safety Operating Trust Fund and the remaining revenues shall be deposited into the General Revenue Fund.

Section 6. Subsection (3) of section 322.221, Florida Statutes, is amended to read:

322.221 Department may require reexamination.-

- (3) (a) Upon the conclusion of such examination or reexamination the department shall take action as may be appropriate and may suspend or revoke the license of such person or permit him or her to retain such license, or may issue a license subject to restrictions as permitted under s. 322.16. Refusal or neglect of the licensee to submit to such examination or reexamination shall be ground for suspension or revocation of his or her license.
- (b) If the department suspends or revokes the license of a person due to his or her physical or mental condition, the department shall issue an identification card to the person at the time of the license suspension or revocation. The department may not charge fees for the issuance of the identification card.
