L. 2002, p. 4349), as amended, is amended by revising Section 4 as follows:

21 "SECTION 4.

The exemption shall be claimed and returned as provided in Code Section 48-5-50.1 of the O.C.G.A. The exemption shall be automatically renewed from year to year as long as the owner occupies the residence as a homestead and does not exceed the income limit in effect in accordance with Section 2. After a person has filed the proper application as

provided in this Act, it shall not be necessary to make application thereafter for any year, and the exemption shall continue to be allowed to such person; provided, however, that such person shall be required to annually submit a copy of his or her federal income tax return for the prior calendar year, by a date to be provided by the governing authority of the City of Commerce or the designee thereof, or such person's exemption granted by this Act shall be suspended until such return or returns are submitted. It shall be the duty of any person granted the homestead exemption under Section 2 to notify the governing authority of the City of Commerce, or the designee thereof, in the event that person for any reason becomes ineligible for that exemption."

- 36 This Act shall become effective on January 1, 2021, and shall apply to all taxable years
- 37 beginning on or after January 1, 2021.
