## A BILL TO BE ENTITLED AN ACT

- 1 To amend Code Section 47-2-226 of the Official Code of Georgia Annotated, relating to
- 2 certain law enforcement officers permitted to obtain creditable service in the Employees'
- 3 Retirement System of Georgia under certain conditions, so as to expand the class of law
- 4 enforcement officers that may obtain creditable service in such retirement system under
- 5 certain conditions; to provide for related matters; to provide conditions for an effective date
- 6 and automatic repeal; to repeal conflicting laws; and for other purposes.

## BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 SECTION 1.

- 9 Code Section 47-2-226 of the Official Code of Georgia Annotated, relating to certain law
- 10 enforcement officers permitted to obtain creditable service in the Employees' Retirement
- 11 System of Georgia under certain conditions, is amended as follows:

- 13 (a) As used in this Code section, the term 'law enforcement officer' means any member in
- service of the Uniform Division of the Department of Public Safety, any conservation
- ranger of the Department of Natural Resources, any officer or agent of the Georgia Bureau
- of Investigation, any district attorney investigator who is compensated from state funds
- pursuant to Code Section 15-18-14.1, and any alcohol and tobacco officer or agent of the
- Department of Revenue, and any investigator of the Department of Driver Services.
- 19 (b) Any law enforcement officer who, prior to becoming a member of this retirement
- system, was employed by a local government in this state as a full-time employee, in a
- 21 position in which he or she was vested with authority to enforce the criminal or traffic laws
- and with the power of arrest and whose duties include the preservation of public order, the
- protection of life and property, or the prevention, detection, or investigation of crime, shall
- be eligible to obtain creditable service under this Code section for his or her years of

26 (1) The member was is not eligible for to receive a present or future benefit from a

- defined benefit or defined contribution retirement or pension plan <u>in which said member</u>
- 28 <u>participated</u> while employed by the local governing authority other than membership in
- 29 the Peace Officers' Annuity and Benefit Fund; and
- 30 (2) The member has been a member of the retirement system for at least ten years.
- 31 (c) Any member eligible as provided in subsection (b) of this Code section may obtain up
- 32 to an additional five years of creditable service, not to exceed the actual number of years
- of service described in subsection (b) of this Code section. In order to obtain such
- additional creditable service, the member shall:
- 35 (1) Make application to the board of trustees in such manner and provide such
- documentation as the board deems appropriate; and
- 37 (2) Pay to the board of trustees an amount determined by the board of trustees to be
- 38 sufficient to cover the full actuarial cost of granting the creditable service as provided in
- 39 this Code section.
- 40 (d) Upon receipt of an application for additional creditable service, the board of trustees
- shall certify to the applicant the amount of the payment required by paragraph (2) of
- subsection (c) of this Code section."

43 SECTION 2.

- 44 This Act shall become effective on July 1, 2018, only if it is determined to have been
- 45 concurrently funded as provided in Chapter 20 of Title 47 of the Official Code of Georgia
- 46 Annotated, the "Public Retirement Systems Standards Law"; otherwise, this Act shall not
- 47 become effective and shall be automatically repealed in its entirety on July 1, 2018, as
- 48 required by subsection (a) of Code Section 47-20-50.

49 SECTION 3.

50 All laws and parts of laws in conflict with this Act are repealed.
