## A BILL TO BE ENTITLED AN ACT

- 1 To amend an Act creating a new charter for the City of Garden City, approved April 17, 1973
- 2 (Ga. L. 1973, p. 3581), as amended, so as to revise provisions regarding the mayor and the
- 3 mayor pro tempore and organizational meetings of the city council; to provide for an
- 4 effective date; to provide for related matters; to repeal conflicting laws; and for other
- 5 purposes.

## BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 SECTION 1.

- 8 An Act creating a new charter for the City of Garden City, approved April 17, 1973
- 9 (Ga. L. 1973, p. 3581), as amended, is amended by revising subsection (b) of Section 2.03,
- subsection (d) of Section 2.06, and subsection (b) of Section 2.12 as follows:
- 11 "(b) Commencing with the general election on the Tuesday following the first Monday in
- November, 2011, the city shall elect a mayor at large for a term of four years. After each
- regular election, the city council shall meet for organization at its first regular meeting next
- 14 following the meeting where the oath of office has been administered. If the mayor has
- been elected at the recent election, he or she shall appoint one of the other councilpersons
- to serve as mayor pro tempore for a four-year term and until his or her successor is elected

and qualified. If the mayor pro tempore leaves office before his or her term has expired, he or she shall be replaced by the mayor. The mayor pro tempore shall act as mayor during any absence or disability of the mayor but shall only vote once on matters before the council and, if a vacancy occurs in the office of mayor, shall become mayor for the remainder of the unexpired term. The city council shall also, by majority vote of all the members, elect one of their number, other than the mayor or mayor pro tempore, to be president of council who shall temporarily assume the mayor's position in the event that the mayor and mayor pro tempore are both unavailable, but who shall not, by virtue of being president of council, become mayor in the event that any vacancy occurs in such office. The president of council shall serve for a term of two years and until his or her successor is elected and qualified. If the president of council leaves office before his or her term has expired, he or she shall be replaced by a majority vote of city council at any regular meeting of city council." "(d) Subject to Section 2.03 of this charter providing that the mayor pro tempore shall fill any vacancy in the mayor's office and further providing that the mayor shall fill any vacancy in the mayor pro tempore's office, in the event that the office of a council member shall become vacant for any cause whatsoever, said vacancy in office shall be filled by appointment by the remaining members of city council." "(b) The city council shall meet for organization at its first regular meeting next following the meeting where the oath of office has been administered. At such meeting, the mayor, if elected in the most recent election, shall appoint one of the other councilpersons to serve as mayor pro tempore for a four-year term and until his or her successor is elected and qualified. In addition, the city council by majority vote of all the members thereof, shall elect one of their number, other than the mayor and mayor pro tem, to be president of council who shall serve for a term of two years and until his or her successor is elected and LC 44 2813/AP

- 44 This Act shall become effective upon its approval by the Governor or upon its becoming law
- 45 without such approval, but no sooner than the date on which the four-year term of the current
