The House Committee on Judiciary Non-Civil offers the following substitute to HB 383:

A BILL TO BE ENTITLED AN ACT

1 To amend Article 2 of Chapter 5 of Title 16 of the Official Code of Georgia Annotated, 2 relating to assault and battery and related offenses against persons, so as to provide for 3 enhanced penalties for aggravated assault and aggravated battery committed upon emergency 4 health workers and healthcare workers in certain circumstances; to provide for a definition; 5 to amend Title 31 of the Official Code of Georgia Annotated, relating to health, so as to 6 provide for P.O.S.T. certified peace officers employed by hospitals to serve as hospital peace 7 officers; to provide for law enforcement authority of hospital peace officers on hospital 8 campuses; to provide for certification requirements of hospital peace officers; to provide for 9 reporting and records requirements; to provide for definitions; to provide for a short title; to 10 provide for an effective date and applicability; to repeal conflicting laws; and for other 11 purposes.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

- 81 <u>Each hospital which employs hospital peace officers shall report to the Georgia Bureau of</u>

86	Law enforcement records created, received, or maintained by a hospital peace officer that
87	relate to the investigation of criminal conduct and crimes as defined under Georgia law and
88	which are not subject to protection from disclosure by any other Georgia law shall be made
89	available within a reasonable time after request for public inspection and copying."

90 **SECTION 6.**

91 Sections 2, 3, and 4 of this Act shall become effective on July 1, 2023, and shall apply to all 92 offenses committed on or after such date. All other sections of this Act shall become 93 effective upon the approval of this Act by the Governor or upon its becoming law without 94 such approval.

95 **SECTION 7.**

96 All laws and parts of laws in conflict with this Act are repealed.
