## A BILL TO BE ENTITLED AN ACT

- 1 To amend an Act creating the Board of Commissioners of Gwinnett County, approved
- 2 January 31, 1968 (Ga. L. 1968, p. 2003), as amended, particularly by an Act approved
- 3 April 25, 2002 (Ga. L. 2002, p. 4258) and by an Act approved September 21, 2011 (Ga. L.
- 4 2011 Ex. Sess., p. 296), so as to reconstitute the board of commissioners; to change the
- 5 description of the commissioner districts; to provide for two additional districts; to provide
- 6 for definitions and inclusions; to provide for election and terms of office of subsequent
- 7 members; to change quorum provisions; to provide for related matters; to provide for
- 8 effective dates; to repeal conflicting laws; and for other purposes.

## BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

SECTION 1.

- An Act creating the board of commissioners of Gwinnett County, approved January 31, 1968
- 12 (Ga. L. 1968, p. 2003), as amended, particularly by an Act approved April 25, 2002 (Ga. L.
- 13 2002, p. 4258) and by an Act approved September 21, 2011 (Ga. L. 2011 Ex. Sess., p. 296),
- is amended by revising Section 3 to read as follows:

15 "SECTION 3.

- 16 (a) Until January 1, 2019, the Board of Commissioners of Gwinnett County shall consist
- of four members and a chairperson. On and after January 1, 2019, the Board of
- 18 Commissioners of Gwinnett County shall consist of six members and a chairperson. The
- chairperson shall be elected by the qualified voters of the entire county and may reside in
- any district in Gwinnett County, but each candidate for membership on the board shall be
- a resident of the commissioner district created by this section which he or she offers to
- represent and shall be elected by the qualified voters of such district. The chairperson and
- 23 members of the board of commissioners shall be elected by majority vote.

24 (b) The six commissioner districts shall be and correspond to those six numbered districts 25 described in and attached to and made a part of this Act and further identified as 'Plan: 26

- gwincc-6d-p1-2017 Plan Type: Local Administrator: H096 User: bak'.
- 27 (c)(1) For the purposes of such plan:
- 28 (A) The term 'VTD' shall mean and describe the same geographical boundaries as 29 provided in the report of the Bureau of the Census for the United States decennial 30 census of 2010 for the State of Georgia. The separate numeric designations in a district description which are underneath a 'VTD' heading shall mean and describe individual 31
- 32 Blocks within a VTD as provided in the report of the Bureau of the Census for the
- 33 United States decennial census of 2010 for the State of Georgia; and
- 34 (B) Except as otherwise provided in the description of any district, whenever the
- 35 description of any district refers to a named city, it shall mean the geographical
- 36 boundaries of that city as shown on the census maps for the United States decennial
- 37 census of 2010 for the State of Georgia.
- 38 (2) Any part of Gwinnett County which is not included in any district described in
- subsection (b) of this section shall be included within that district contiguous to such part 39
- 40 which contains the least population according to the United States decennial census of
- 41 2010 for the State of Georgia.
- 42 (3) Any part of Gwinnett County which is described in subsection (b) of this section as
- 43 being included in a particular district shall nevertheless not be included within such
- 44 district if such part is not contiguous to such district. Such noncontiguous part shall
- 45 instead be included within that district contiguous to such part which contains the least
- 46 population according to the United States decennial census of 2010 for the State of
- 47 Georgia.
- 48 (d)(1) The members of the reconstituted Board of Commissioners of Gwinnett County
- shall be elected as provided in this subsection. Those members of the board elected from 49
- Commissioner Districts 2 and 4 and the first board member from Commissioner District 50
- 51 6 shall be elected at the general election on the Tuesday next following the first Monday
- 52 in November, 2018. Those members of the board elected from Commissioner Districts
- 2, 4, and 6 shall take office the first day of January immediately following that election 53
- and shall serve for initial terms of office which expire December 31, 2022, and upon the 54
- 55 election and qualification of their respective successors.
- (2) The first board member from Commissioner District 5 shall be elected in the general 56
- election on the Tuesday next following the first Monday in November, 2018, and shall 57
- take office the first day of January immediately following that election and shall serve for 58
- 59 an initial term of office which expires December 31, 2020, and upon the election and
- 60 qualification of the board member's successor.

(3) The chairperson and those members from Commissioner Districts 1, 3, and 5 shall be elected at the general election on the Tuesday next following the first Monday in November, 2020. The chairperson and those members of the board elected from Commissioner Districts 1, 3, and 5 shall take office the first day of January immediately following that election and shall serve for initial terms of office which expire December

31, 2024, and upon the election and qualification of their respective successors.

- (4) Those and all future successors to members of the board whose terms of office are to expire shall be elected at the time of the state-wide general election preceding the expiration of such terms, shall take office the first day of January immediately following that election, and shall serve for terms of office of four years each. Members of the board shall serve for the terms of office specified in this subsection and until their respective
- successors are elected and qualified.

- (e) Commissioner Districts 1, 2, 3, and 4, as they exist on July 1, 2017, shall continue to be designated as Commissioner Districts 1, 2, 3, and 4, respectively, but as newly described under this Act; and on and after July 1, 2017, such members of the board serving from those former commissioner districts shall be deemed to be serving from and representing
- their respective districts as newly described under this Act.
- 78 (f) All members of the board shall be nominated and elected in accordance with Chapter 79 2 of Title 21 of the O.C.G.A., the 'Georgia Election Code.'"

80 SECTION 2.

- Said Act is further amended by striking in its entirety the attachment thereto containing the descriptions of the four commissioner districts which is identified as "Plan: gwinnettcc-2011re2 Plan Type: Local User: bak."
- SECTION 3.
- 85 Said Act is further amended by revising Section 9 to read as follows:

86 "SECTION 9.

The board of commissioners shall hold regular meetings on the first and third Tuesdays of each month at 10:00 A.M. and on the fourth Tuesday of each month at 7:00 P.M. Work sessions will be held on the second and fourth Tuesdays of each month at a time to be designated by the board of commissioners. At the evening meetings on the fourth Tuesday, the board of commissioners shall hear applications for rezoning. These meetings, work sessions, and other meetings shall be held at the county seat or such other location within the county as the board of commissioners designates and shall be open to the public. The board of commissioners shall be authorized to change the scheduled time of the regular

meetings and the day and time of the work sessions by duly adopted resolution, provided that notice of such change shall be published in a newspaper of general circulation and in the official county organ for three weeks within a period of 60 days prior to the adoption of the resolution. The board of commissioners may hold such additional meetings as shall be necessary when called by the chairperson or any three members of the board of commissioners, provided that all members shall have been notified at least three days in advance of such special meeting. No official action shall be taken by the board of commissioners except in a meeting which is open to the public. The chairperson and any four members of the board of commissioners, exclusive of the chairperson, shall constitute a quorum. No official action shall be taken except upon the affirmative vote of at least five members of the board of commissioners. The chairperson shall be entitled to the same voting rights as other members of the board of commissioners on questions considered by the board."

**SECTION 4.** 

This Act shall become effective upon its approval by the Governor or upon its becoming law without such approval, except Section 3 of this Act shall become effective January 1, 2019.

111 SECTION 5.

All laws and parts of laws in conflict with this Act are repealed.
