A BILL TO BE ENTITLED AN ACT

- 1 To amend Chapter 5 of Title 19 of the Official Code of Georgia Annotated, relating to
- 2 divorce, so as to create a pet animal care plan in marriage dissolution proceedings; to provide
- 3 definitions; to provide for related matters; to repeal conflicting laws; and for other purposes.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

5 SECTION 1.
6 Chapter 5 of Title 19 of the Official Code of Georgia Annotated, relating to divorce, is
7 amended by adding a new Code section to read as follows:
8 "19-5-18.
9 (a) As used in this Code section, the term:
10 (1) 'Pet animal' means any domesticated animal that is joint marital property and kept as

11 <u>a household companion animal.</u>

(2) 'Pet animal care plan' means a written plan for a pet animal that provides for, but is not limited to, the prevention of acts of cruelty or harm and the provision of food, water,

veterinary care, and safe and protected shelter.

(b)(1) In all cases of divorce in which the custody of a pet animal is at issue between the parties, the court shall make a determination of whether the parties have joint ownership over the pet animal and whether the pet animal was purchased or acquired during the marriage.

(2) The court at the request of a party to proceedings for dissolution of marriage or for legal separation of the parties may enter an order, prior to the final determination of ownership of a pet animal, to require a party to care for the pet animal. The existence of an order providing for the care of a pet animal during the course of such proceedings shall

23 <u>not have any impact on the court's final determination of ownership of the pet animal.</u>

(c)(1) If the court finds that such pet animal is jointly owned by the parties and was purchased or acquired during the marriage, the court may require each party to prepare

a pet animal care plan or may require the parties to jointly submit a pet animal care plan.

27	Any final order of divorce shall incorporate any pet animal care plan submitted pursuant
28	to this Code section.
29	(2) Unless otherwise ordered by the court, a pet animal care plan shall include the
30	<u>following:</u>
31	(A) A recognition that a close and continuing owner-pet animal relationship and
32	continuity in the pet animal's life will be in the pet animal's best interest;
33	(B) A recognition that the pet animal's needs will change and grow as the pet animal
34	matures and demonstrate that the owners will make an effort to provide care that takes
35	this issue into account so that future modifications to the pet animal care plan are
36	minimized;
37	(C) A recognition that a party with physical custody will make day-to-day decisions
38	and emergency decisions while the pet animal is residing with such owner;
39	(D) That both owners will have access to all of the pet animal's records and
40	information, including, but not limited to, health and activities;
41	(E) Where and when a pet animal will be in each owner's physical care, designating
42	where the pet animal will spend each day of the year;
43	(F) Transportation arrangements, including how the pet animal will be exchanged
44	between the owners, the location of the exchange, how the transportation costs will be
45	paid, and any other matter relating to the pet animal spending time with each party;
46	(G) An allocation of decision-making authority to one or both of the owners with
47	regard to the pet animal's health and activities, and if the owners agree the matters
48	should be jointly decided, how to resolve a situation in which the owners disagree on
49	resolution; and
50	(H) What, if any, limitations will exist while one party has physical custody of the pet
51	animal in terms of the other party's right to access health and other activities regarding
52	the pet animal."

53 SECTION 2.

All laws and parts of laws in conflict with this Act are repealed.
