A BILL TO BE ENTITLED AN ACT

- 1 To amend Title 2 of the Official Code of Georgia Annotated, relating to agriculture, so as to
- 2 authorize the Department of Agriculture to enforce certain criminal laws; to amend Article 2
- 3 of Chapter 7 of Title 16 of the Official Code of Georgia, relating to criminal trespass and
- 4 damage to property, so as to provide for the offense of criminal trespass involving a wild
- 5 animal; to provide for definitions; to provide for penalties; to provide for an exception; to
- 6 amend Code Section 16-8-20 of the Official Code of Georgia Annotated, relating to livestock
- 7 theft, so as to provide for increased penalties; to provide for related matters; to repeal
- 8 conflicting laws; and for other purposes.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

SECTION 1.

- 11 Title 2 of the Official Code of Georgia Annotated, relating to agriculture, is amended in Code
- 12 Section 2-2-13, relating to enforcement of laws and rules within jurisdiction of the
- 13 Commissioner and employment of investigators, by revising subsections (a), (b), and (d) as
- 14 follows:

- 15 "(a) The Commissioner shall be vested with police powers to enforce those laws governing
- matters within the jurisdiction of the Commissioner or the department as provided by this

title and Titles 4, 10, <u>16</u>, 26, and 43 and the rules and regulations adopted pursuant thereto

- and to prevent, detect, and respond to acts of bioterrorism, other terroristic acts or threats,
- or natural disasters affecting or potentially affecting plants, animals, products, or facilities
- that are subject to regulation by the department.
- 21 (b) The Commissioner shall be authorized to employ, designate, and deputize investigators
- and to delegate to such employees of the department the necessary authority to enforce
- 23 those laws governing matters within the jurisdiction of the Commissioner or the department
- as provided by this title and Titles 4, 10, 16, 26, and 43 and the rules and regulations
- adopted pursuant thereto and to prevent, detect, and respond to acts of bioterrorism, other
- 26 terroristic acts or threats, or natural disasters affecting or potentially affecting plants,
- animals, products, or facilities that are subject to regulation by the department. Employees
- 28 who have been so designated by the Commissioner and who have been certified by the
- 29 Georgia Peace Officer Standards and Training Council as having successfully completed
- 30 the course of training required by Chapter 8 of Title 35, the 'Georgia Peace Officer
- 31 Standards and Training Act,' shall be authorized:
- 32 (1) To carry firearms authorized or issued by the Commissioner while in the performance
- of their duties;
- 34 (2) To inspect plants, animals, products, or facilities when the same are subject to
- regulation by the department;
- 36 (3) To stop and inspect any vehicle transporting plants, animals, or products when the
- same are subject to regulation by the department;
- 38 (4) To inspect and require the production of health certificates, waybills, permits, or
- 39 other documents required by federal or state laws, rules, regulations, or orders for the
- 40 transportation of plants, animals, or products when the same are subject to regulation by
- 41 the department;
- 42 (5) To protect any life or property when the circumstances demand action; and

43 (6) To arrest any person found to be in violation of a criminal law when enforcement of such law is authorized under this subsection."

"(d) This Code section shall not repeal, supersede, alter, or affect the power of any other law enforcement officer of this state or of any county, municipality, or other political subdivision of this state. At the request of the Commissioner of Agriculture, it shall be the duty of all state, county, municipal, and other law enforcement officers in this state to enforce and to assist the Commissioner and the employees and agents of the department in the enforcement of those laws governing matters within the jurisdiction of the Commissioner or the department as provided by this title and Titles 4, 10, 16, 26, and 43."

- 53 Article 2 of Chapter 7 of Title 16 of the Official Code of Georgia, relating to criminal
- 54 trespass and damage to property, is amended by adding a new Code section to read as

- 56 "16-7-21.1
- 57 (a) As used in this Code section, the term:
- 58 (1) 'Harass' means to engage in any act which demonstrates a disregard for the
- 59 <u>well-being of a wild animal, or which creates the likelihood of injury to or disrupts</u>
- normal behavior patterns of the wild animal, such as feeding, watering, resting, and
- 61 <u>breeding.</u>
- 62 (2) 'Wild animal' means any land or sea animal currently or historically found in the
- 63 wild, other than a domestic animal or livestock, including an animal kept, exhibited, or
- 64 <u>housed at any facility operating with the purpose of public visitation, conservation,</u>
- 65 education, or science, including but not limited to a zoological institution as defined in
- paragraph (87) of Code Section 48-8-3, and any animal kept, exhibited, or housed in
- 67 <u>aquariums, safaris, or animal sanctuaries.</u>

(b)(1) A person commits the offense of criminal trespass involving a wild animal in the

- 69 <u>first degree if such person enters a cage, enclosure, or other area where a wild animal is</u>
- housed or otherwise contained, into which the person knows he or she has no legal
- 71 <u>authority, license, or permission to enter, and harasses the wild animal and such wild</u>
- 72 <u>animal suffers an injury or death.</u>
- 73 (2) A person commits the offense of criminal trespass involving a wild animal in the
- second degree if such person enters a cage, enclosure, or other area where a wild animal
- is housed or otherwise contained, into which the person knows he or she has no legal
- authority, license, or permission to enter.
- 77 (c)(1) A person convicted of the offense of criminal trespass involving a wild animal in
- the first degree shall be guilty of a felony and shall be punished by imprisonment for not
- 79 <u>less than one nor more than ten years.</u>
- 80 (2) A person convicted of the offense of criminal trespass involving a wild animal in the
- 81 second degree shall be guilty of a misdemeanor and punished by imprisonment for not
- 82 more than 12 months.
- 83 (d) In addition to any other fine, penalty, or restitution which may be imposed by law, such
- 84 person would be liable for the cost of any damage to, and loss of, property connected to the
- 85 <u>criminal trespass, including, but not limited to, the injury or death of the wild animal.</u>
- 86 (e) It shall not be an affirmative defense to prosecution under this Code section that:
- 87 (1) Entry into the cage, enclosure, or other area where the wild animal was housed or
- 88 <u>otherwise contained was not sufficiently guarded, locked, or otherwise made inaccessible</u>
- so as to prevent entry into the cage, enclosure, or other area;
- 90 (2) The wild animal was provoked by means other than the presence of the person in the
- 91 <u>cage, enclosure, or other area; or</u>
- 92 (3) Injury to the wild animal was necessary to protect the person from injury or death.

93	(f) Subsection (b) of this Code section shall not apply to a person who enters a cage,
94	enclosure, or other area for the purpose of aiding another person or a wild animal in the
95	cage, enclosure, or other area."

96 SECTION 3.

- Code Section 16-8-20 of the Official Code of Georgia Annotated, relating to livestock theft,
 is amended by revising subsection (c) as follows:
- 99 "(c) Any person committing the offense of livestock theft commits shall be guilty of a 100 felony and, upon conviction thereof, shall be punished by imprisonment for not less than 101 one two nor more than ten 15 years and by a fine of \$1,000.00 \$10,000.00; provided, 102 however, that, if the fair market value of the livestock taken or appropriated is \$100.00 or 103 less, the person shall be guilty of a misdemeanor of a high and aggravated nature."
