- 3 WHEREAS, J. Frank "Mr. Peanut Man" McGill has long been recognized by the citizens
- 4 of this state for the vital role that he has played in leadership and his deep personal
- 5 commitment to the welfare of the citizens of Georgia; and
- 6 WHEREAS, Frank has diligently and conscientiously devoted innumerable hours of his time,
- 7 talents, and energy toward the betterment of his community and state as evidenced
- 8 dramatically by his superlative service within the Georgia agriculture industry; and
- 9 WHEREAS, he served as a county Extension agent, the Georgia Extension Service's general
- agronomist and peanut specialist, and as a peanut consultant with M&M Mars; and
- 11 WHEREAS, Frank was a member of the University of Georgia's Extension peanut team that
- developed a multi-discipline approach for Georgia peanut production; during his tenure with
- the team, Georgia's peanut yield increased from 955 pounds per acre in 1955 to 3,220 pounds
- 14 per acre in 1974; and
- 15 WHEREAS, his work also went global; Frank was invited to 16 countries across five
- 16 continents to review research and Extension programs, as well as to assist with peanut
- 17 production in underdeveloped countries to aid in the fight against hunger; and
- 18 WHEREAS, during his career, Frank served as the president of the American Research and
- 19 Education Society; chairman of the University of Georgia Agronomists, the United States
- 20 Task Force on Peanut Policy, and the United States Peanut Improvement Working Group;
- 21 he was a technical adviser to the Georgia Peanut Commission, the United States Senate
- 22 Agriculture Committee, the National Peanut Council, and the National Peanut Growers

- 25 industry, including being named Man of the Year by Progressive Farmer Magazine and
- being awarded the D.W. Brooks Distinguished Professor of Agronomy; and
- 27 WHEREAS, Frank became the first member of the Georgia Peanut Hall of Fame and was
- 28 presented with the Lifetime Achievement Award by the Georgia Peanut Hall of Fame in
- 29 1999; he also received an award as a distinguished faculty member at the University of
- 30 Georgia and the Distinguished Alumnus Award from Abraham Baldwin Agricultural
- 31 College; and
- WHEREAS, he is a person of magnanimous strengths with an unimpeachable reputation for
- 33 integrity, intelligence, fairness, and kindness; and
- 34 WHEREAS, it is abundantly fitting and proper that the outstanding accomplishments of this
- 35 remarkable and distinguished Georgian be appropriately recognized.
