- 1 Welcoming and commending the Honorable Ko, Wen-je, Mayor of Taipei City; and for other
- 2 purposes.
- 3 WHEREAS, respecting freedom, human rights, and the rule of law, Taiwan shares the core
- 4 values of democracy with our country and the State of Georgia; and
- 5 WHEREAS, Taiwan is the United States' 11th largest trading partner and Georgia's 6th
- 6 largest export destination in Asia, totaling nearly \$520 million in 2016; and
- 7 WHEREAS, 2019 is the dual fortieth anniversary of the Taiwan Relations Act that the
- 8 Congress of the United States passed in 1979 and on November 5, 1979, the city of Taipei
- 9 entered into a sister-city relationship with the City of Atlanta; and
- 10 WHEREAS, the Taiwan Relations Act is to help maintain peace, security, and stability in the
- 11 Western Pacific and to promote the foreign policy of the United States by authorizing the
- 12 continuation of commercial, cultural, and other relations between the people of the United
- 13 States and the people on Taiwan, and for other purposes; and
- 14 WHEREAS, since 1984, the State of Georgia and Taiwan have enjoyed long, cordial, and
- mutually beneficial sister-statehood, through culture exchange and trade investment between
- 16 their two Capitols, Atlanta and Taipei, a friendship that has continued to strengthen for the
- 17 past 35 years; and
- 18 WHEREAS, for the benefit of all citizens, the people of both Atlanta, Georgia, and Taipei,
- 19 Taiwan, will endeavor to strengthen exchange programs in the fields of the fintech, biotech,
- 20 smart city, investment, education, culture, tourism, workforce innovation, and sustainable
