A BILL TO BE ENTITLED AN ACT

- 1 To amend Code Section 38-2-151 of the Official Code of Georgia Annotated, relating to
- 2 adjutant general, duties, records, seal, and effect on documentary evidence, so as to remove
- 3 the requirement that the adjutant general include a roster of all commissioned officers in the
- 4 organized militia in the annual report to the Governor; to provide for the removal of the
- 5 requirement that the laws and regulations of such militia shall be indexed, printed, bound,
- 6 and distributed to all forces of the militia; to provide for related matters; to repeal conflicting
- 7 laws; and for other purposes.

8 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

9 SECTION 1.

- 10 Code Section 38-2-151 of the Official Code of Georgia Annotated, relating to adjutant
- 11 general, duties, records, seal, and effect on documentary evidence, is amended as follows:
- 12 "38-2-151.
- 13 (a) The adjutant general shall be chief of staff to the Governor and subordinate only to the
- 14 Governor in matters pertaining to the Department of Defense and the military and naval
- 15 affairs of the state.

16 (b) Whenever the Governor and those who would act in succession to him or her under the

- 17 Constitution and laws of the state are unable to perform the duties of commander in chief,
- 18 the adjutant general shall command the militia.
- 19 (c) It shall be the duty of the adjutant general:
- 20 (1) To direct the planning and employment of the forces of the organized militia in
- 21 carrying out their state military mission;
- 22 (2) To establish unified command of state forces whenever they are jointly engaged; and
- 23 (3) To coordinate the military and naval affairs with the emergency management agency
- of the state.
- 25 (d) The adjutant general shall:
- 26 (1) Be custodian of all military records and shall keep the same indexed and available
- 27 for ready reference;
- 28 (2) Keep an itemized account of all moneys received and disbursed from all sources; and
- 29 (3) Make an annual report to the Governor on the condition of the organized militia with
- 30 a roster of all commissioned officers and such other matters relating to the Military
- Division, Department of Defense as he the adjutant general shall deem expedient.; and
- 32 (4) Cause the laws and regulations relating to the militia to be indexed, printed, bound,
- and distributed to all forces of the organized militia.
- 34 (e) The adjutant general shall further perform such duties pertaining to his the office as
- 35 from time to time may be provided by the laws, rules, and regulations of the United States
- and such as may be designated by the Governor.
- 37 (f) The adjutant general shall have a seal of office approved by the Governor, and all
- 38 copies and papers in the Military Division, Department of Defense which are duly certified
- 39 and authenticated under the seal shall be evidence in like manner as if the original were
- 40 produced."
