The Senate Committee on Judiciary offered the following substitute to SB 287:

## A BILL TO BE ENTITLED AN ACT

- 1 To amend Chapter 3 of Title 17 of the Official Code of Georgia Annotated, relating to
- 2 limitations on prosecution, so as to revise the statute of limitations on the offenses of rape,
- 3 aggravated sodomy, and aggravated sexual battery; to provide that a prosecution for the

8 SECTION 1.

- 9 Chapter 3 of Title 17 of the Official Code of Georgia Annotated, relating to limitations on 10 prosecution, is amended by revising Code Section 17-3-1, relating to limitations on
- 11 prosecution generally, as follows:
- 12 "17-3-1.
- 13 (a) A prosecution for murder may be commenced at any time.
- 14 (b) For crimes of rape, aggravated sodomy, or aggravated sexual battery committed on or
- 15 <u>after July 1, 2020, a prosecution for such crimes may be commenced at any time.</u>
- 16 (b)(c) Except as otherwise provided in Code Section 17-3-2.1, prosecution for other crimes
- punishable by death or life imprisonment shall be commenced within seven years after the
- commission of the crime except as provided by subsection (d) (e) of this Code section;
- 19 provided, however, that prosecution for the crime of forcible rape shall be commenced
- within 15 years after the commission of the crime for offenses committed prior to July 1,
- 21 <u>2020</u>.
- 22 (c)(d) Except as otherwise provided in Code Section 17-3-2.1, prosecution for felonies
- other than those specified in subsections (a), (b), (c), and (d) (e) of this Code section shall
- 24 be commenced within four years after the commission of the crime, provided that
- 25 prosecution for felonies committed against victims who are at the time of the commission

of the offense under the age of 18 years shall be commenced within seven years after the

- 27 commission of the crime.
- 28 (d)(e) A prosecution for the following offenses may be commenced at any time when
- 29 deoxyribonucleic acid (DNA) evidence is used to establish the identity of the accused:
- 30 (1) Armed robbery, as defined in Code Section 16-8-41;
- 31 (2) Kidnapping, as defined in Code Section 16-5-40; or
- 32 (3) Rape, as defined in Code Section 16-6-1 for offenses committed prior to July 1, 2020;
- 33 (4) Aggravated child molestation, as defined in Code Section 16-6-4;
- 34 (5) Aggravated sodomy, as defined in Code Section 16-6-2 for offenses committed prior
- 35 <u>to July 1, 2020</u>; or
- 36 (6) Aggravated sexual battery, as defined in Code Section 16-6-22.2 for offenses
- 37 <u>committed prior to July 1, 2020;</u>
- provided, however, that a sufficient portion of the physical evidence tested for DNA is
- 39 preserved and available for testing by the accused and provided, further, that if the DNA
- 40 evidence does not establish the identity of the accused, the limitation on prosecution shall
- be as provided in subsections (b) and (c) and (d) of this Code section.
- 42 (e)(f) Prosecution for misdemeanors shall be commenced within two years after the
- 43 commission of the crime."
