A BILL TO BE ENTITLED AN ACT

To amend an Act reconstituting the Board of Education of Lee County, approved April 9,
 1993 (Ga. L. 1993, p. 5130), as amended, so as to change the description of the education
 districts; to define certain terms and provide for certain inclusions; to provide for
 continuation in office of current members; to provide for related matters; to provide effective
 dates; to repeal conflicting laws; and for other purposes.

6 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

SECTION 1.

8 An Act reconstituting the Board of Education of Lee County, approved April 9, 1993 (Ga.9 L. 1993, p. 5130), as amended, is amended by revising Section 2 as follows:

10 "SECTION 2.
11 (a) Those members of the Board of Education of Lee County who are serving as such on
12 the effective date of this Act and any person selected to fill a vacancy in any such office
13 shall continue to serve as such members until the regular expiration of their respective
14 terms of office and upon the election and qualification of their respective successors. The

Board of Education of Lee County shall consist of five members all of whom shall beelected from education districts described in subsection (b) of this section.

(b) For the purpose of electing members of the board of education, the Lee County School
District shall be divided into five education districts. Districts 1, 2, 3, 4, and 5 shall be and
correspond to those five numbered districts described in Appendix A attached to and made
a part of this Act and further identified as 'User: Lee Co. Plan Name: LeeCCSB-2022 Plan
Type: Local'.

22 (c)(1) For the purposes of such plan:

(A) The term 'VTD' shall mean and describe the same geographical boundaries as
provided in the report of the Bureau of the Census for the United States decennial
census of 2020 for the State of Georgia. The separate numeric designations in a district
description which are underneath a VTD heading shall mean and describe individual
Blocks within a VTD as provided in the report of the Bureau of the Census for the
United States decennial census of 2020 for the State of Georgia; and

(B) Except as otherwise provided in the description of any district, whenever the
description of any district refers to a named city, it shall mean the geographical
boundaries of that city as shown on the census maps for the United States decennial
census of 2020 for the State of Georgia.

33 (2) Any part of the Lee County School District which is not included in any district
34 described in subsection (b) of this section shall be included within that district contiguous
35 to such part which contains the least population according to the United States decennial
36 census of 2020 for the State of Georgia.

37 (3) Any part of the Lee County School District which is described in subsection (b) of
38 this section as being included in a particular district shall nevertheless not be included
39 within such district if such part is not contiguous to such district. Such noncontiguous
40 part shall instead be included within that district contiguous to such part which contains

SECTION 2.

44 Districts 1, 2, 3, 4, and 5, as they exist immediately prior to the effective date of this Act, 45 shall continue to be designated as Districts 1, 2, 3, 4, and 5, respectively, but as newly 46 described under this Act, and on and after the effective date of this Act, such members of the 47 board serving from those former districts shall be deemed to be serving from and 48 representing their respective districts as newly described under this Act.

SECTION 3.

50 The provisions of this Act necessary to conduct elections for the members of the Board of 51 Education of Lee County in 2022 shall become effective upon the approval of this Act by the

52 Governor or upon its becoming law without such approval. The remaining provisions of this

53 Act shall become effective on January 1, 2023.

SECTION 4.

55 All laws and parts of laws in conflict with this Act are repealed.
