A BILL TO BE ENTITLED AN ACT

1 To amend an Act creating the Board of Commissioners of Gwinnett County, approved 2 January 31, 1968 (Ga. L. 1968, p. 2003), as amended, particularly by an Act approved 3 March 24, 1988 (Ga. L. 1988, p. 4658), an Act approved April 1, 1994 (Ga. L. 1994, 4 p. 4497), and by an Act approved September 21, 2011 (Ga. L. 2011 Ex. Sess., p. 296), so as 5 to reconstitute the board of commissioners; to change the description of the commissioner 6 districts; to provide for five additional districts; to provide for definitions and inclusions; to 7 provide for election and terms of office of subsequent members; to change quorum 8 provisions; to provide that the chairperson votes only in the event of a tie; to revise 9 provisions governing the duties of the chairperson; to repeal a superseded description of 10 commissioner districts; to provide for related matters; to provide for effective dates; to repeal 11 conflicting laws; and for other purposes.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

SECTION 1.

20 (a) Until January 1, 2023, the Board of Commissioners of Gwinnett County shall consist 21 of four members and a chairperson. On and after January 1, 2023, the Board of 22 Commissioners of Gwinnett County shall consist of nine members and a chairperson. The 23 chairperson shall be elected by the qualified voters of the entire county and may reside in 24 any district in Gwinnett County, but each candidate for membership on the board shall be 25 a resident of the commissioner district created by this section which he or she offers to 26 represent and shall be elected by the qualified voters of such district. The chairperson and 27 members of the board of commissioners shall be elected by majority vote. 28 (b) The nine commissioner districts shall be and correspond to those nine numbered 29 districts described in Appendix A attached to and made a part of this Act and further 30 identified as 'User: H104 Plan Name: GwinnettCC-2021 Plan Type: Local' 31 (c)(1) For the purposes of such plan: 32 (A) The term 'VTD' shall mean and describe the same geographical boundaries as 33 provided in the report of the Bureau of the Census for the United States decennial 34 census of 2020 for the State of Georgia. The separate numeric designations in a district 35 description which are underneath a 'VTD' heading shall mean and describe individual 36 Blocks within a VTD as provided in the report of the Bureau of the Census for the 37 United States decennial census of 2020 for the State of Georgia; and 38 (B) Except as otherwise provided in the description of any district, whenever the description of any district refers to a named city, it shall mean the geographical 39 40 boundaries of that city as shown on the census maps for the United States decennial

42 (2) Any part of Gwinnett County which is not included in any district described in 43 subsection (b) of this section shall be included within that district contiguous to such part 44 which contains the least population according to the United States decennial census 45 of 2020 for the State of Georgia. 46 (3) Any part of Gwinnett County which is described in subsection (b) of this section as 47 being included in a particular district shall nevertheless not be included within such 48 district if such part is not contiguous to such district. Such noncontiguous part shall 49 instead be included within that district contiguous to such part which contains the least 50 population according to the United States decennial census of 2020 for the State of 51 Georgia. 52 (d)(1) The members of the reconstituted Board of Commissioners of Gwinnett County 53 shall be elected as provided in this subsection. The chairperson and those members of 54 the board elected from Commissioner Districts 1 and 3 shall be elected at the general 55 election on the Tuesday next following the first Monday in November, 2024. The 56 chairperson and those members of the board elected from Commissioner Districts 1 and 3 57 shall take office the first day of January immediately following that election and shall 58 serve for terms of office which expire December 31, 2028, and upon the election and 59 qualification of their respective successors. 60 (2) The first board member from Commissioner Districts 5, 7, and 9 shall be elected in 61 the general election on the Tuesday next following the first Monday in November, 2022, 62 and shall take office the first day of January immediately following that election and shall 63 serve for an initial term of office which expires December 31, 2024, and upon the 64 election and qualification of their respective successors. 65 (3) Those members from Commissioner Districts 2, 4, 6, and 8 shall be elected at the 66 general election on the Tuesday next following the first Monday in November, 2022, and 67 shall take office the first day of January immediately following that election and shall

serve for terms of office which expire December 31, 2026, and upon the election and qualification of their respective successors.

- (4) Except as provided in paragraph (2) of this subsection, those and all future successors to members of the board whose terms of office are to expire shall be elected at the time
- of the state-wide general election preceding the expiration of such terms, shall take office
- the first day of January immediately following that election, and shall serve for terms of
- office of four years each. Members of the board shall serve for the terms of office
- specified in this subsection and until their respective successors are elected and qualified.
- 76 (e) Commissioner Districts 1, 2, 3, and 4, as they exist on the effective date of this Act,
- shall continue to be designated as Commissioner Districts 1, 2, 3, and 4, respectively, but
- as newly described under this Act; and on and after January 1, 2023, such members of the
- 79 board serving from those former commissioner districts shall be deemed to be serving from
- and representing their respective districts as newly described under this Act.
- 81 (f) All members of the board shall be nominated and elected in accordance with Chapter 2
- 82 of Title 21 of the O.C.G.A., the 'Georgia Election Code.'"

- 84 Said Act is further amended by striking in its entirety the attachment thereto containing the
- 85 descriptions of the four commissioner districts which is identified as
- 86 "Plan: gwinnettcc-2011re2 Plan Type: Local User: bak"

SECTION 3.

- 88 Said Act is further amended by revising Section 9 to read as follows:
- 89 "SECTION 9.
- 90 The board of commissioners shall hold regular meetings on the first and third Tuesdays of
- each month at 10:00 A.M. and on the fourth Tuesday of each month at 7:00 P.M. Work

sessions shall be held on the second and fourth Tuesdays of each month at a time to be designated by the board of commissioners. At the evening meetings on the fourth Tuesday, the board of commissioners shall hear applications for rezoning. These meetings, work sessions, and other meetings shall be held at the county seat or such other location within the county as the board of commissioners designates and shall be open to the public. The board of commissioners shall be authorized to change the scheduled time of the regular meetings and the day and time of the work sessions by duly adopted resolution, provided that notice of such change shall be published in a newspaper of general circulation and in the official county organ for three weeks within a period of 60 days prior to the adoption of the resolution. The board of commissioners may hold such additional meetings as shall be necessary when called by the chairperson or any three members of the board of commissioners, provided that all members shall have been notified at least three days in advance of such special meeting. No official action shall be taken by the board of commissioners except in a meeting which is open to the public. The chairperson and any four members of the board of commissioners, or any five members of the board of commissioners, exclusive of the chairperson, shall constitute a quorum. No official action shall be taken except upon the affirmative vote of at least five members of the board of commissioners. The chairperson shall vote only in the event of a tie vote of the commissioners."

- 115 (7) Sharing equal responsibility with other commissioners for the approval of the board 116 of commissioners staff additions or separations; and"

118 Said Act is further amended by repealing subsection (b) of Section 13.

- 120 This Act shall become effective upon its approval by the Governor or upon its becoming law
- 121 without such approval, except Sections 3 and 4 of this Act shall become effective
- 122 January 1, 2023.

123 **SECTION 7.**

124 All laws and parts of laws in conflict with this Act are repealed.
