A RESOLUTION

- 1 Recognizing Mr. Maron Sidney Buice and dedicating a bridge in his honor; and for other
- 2 purposes.
- 3 WHEREAS, Mr. Maron Sidney Buice has long been recognized by the citizens of this state
- 4 for the vital role that he has played in leadership and his deep personal commitment to the
- 5 welfare of the citizens of Georgia; and
- 6 WHEREAS, he diligently and conscientiously devoted innumerable hours of his time,
- 7 talents, and energy toward the betterment of his community and state as evidenced
- 8 dramatically by his 16 years of public service as a Gwinnett County Commissioner; and
- 9 WHEREAS, during his tenure from 1968 to 1984 with the Gwinnett County Board of
- 10 Commissioners, Mr. Buice fought hard for securing safety for the traveling public through
- 11 his work to have signals placed at railroad crossings in North Gwinnett; and
- 12 WHEREAS, Mr. Buice's significant organizational and leadership talents, his remarkable
- patience and diplomacy, his keen sense of vision, and his sensitivity to the needs of the
- 14 citizens of this state earned him the respect and admiration of his colleagues and associates;

- 16 WHEREAS, his influence and determination can be felt today with the countless lives saved
- 17 due to his hard fought battle to ensure a bridge was constructed on Nelson Brogdon
- 18 Boulevard/Highway 20 over the railroad tracks, a crossing that claimed the lives of five
- 19 Forsyth County teenagers in 1970 when their car collided with a train; and
- 20 WHEREAS, it is abundantly fitting and proper that this remarkable and distinguished
- 21 Georgian be recognized appropriately by dedicating a bridge in his honor.

22 NOW, THEREFORE, BE IT RESOLVED AND ENACTED BY THE GENERAL

- 23 ASSEMBLY OF GEORGIA that the bridge on Nelson Brogdon Boulevard/Highway 20
- 24 crossing over the railroad tracks located just before the intersection of Highway 20 and
- 25 Peachtree Industrial Boulevard in Gwinnett County is dedicated as the Maron Sidney Buice
- 26 Bridge.
- 27 BE IT FURTHER RESOLVED that the Department of Transportation is authorized and
- 28 directed to erect and maintain appropriate signs dedicating the Maron Sidney Buice Bridge.
- 29 BE IT FURTHER RESOLVED that the Secretary of the Senate is authorized and directed
- 30 to make appropriate copies of this resolution available for distribution to Mr. Maron Sidney
- 31 Buice and to the Department of Transportation.
