1 AN ACT  
 2 RELATING TO THE APPROPRIATION TO THE WORKFORCE DEVELOPMENT COUNCIL; APPRO-  
 3 PRIATING ADDITIONAL MONEYS TO THE WORKFORCE DEVELOPMENT COUNCIL FOR  
 4 FISCAL YEAR 2025; AUTHORIZING ADDITIONAL FULL-TIME EQUIVALENT POSI-  
 5 TIONS; PROVIDING REAPPROPRIATION AUTHORITY FOR THE ARPA STATE FISCAL  
 6 RECOVERY FUND; PROVIDING REAPPROPRIATION AUTHORITY FOR THE ARPA STATE  
 7 FISCAL RECOVERY FUND; PROVIDING REAPPROPRIATION AUTHORITY FOR THE  
 8 IN-DEMAND CAREERS FUND; PROVIDING REAPPROPRIATION AUTHORITY FOR THE  
 9 WORKFORCE DEVELOPMENT TRAINING FUND; AND DECLARING AN EMERGENCY AND  
 10 PROVIDING AN EFFECTIVE DATE.

11 Be It Enacted by the Legislature of the State of Idaho:

12 SECTION 1. In addition to any other appropriation provided by law,  
 13 there is hereby appropriated to the Workforce Development Council the fol-  
 14 lowing amounts to be expended according to the designated expense classes  
 15 from the listed funds for the period July 1, 2024, through June 30, 2025:

30 SECTION 2. FTP AUTHORIZATION. In addition to any other authorization  
 31 provided by law, the full-time equivalent position authorization provided  
 32 to the Workforce Development Council is hereby increased by three (3.00) for  
 33 the period July 1, 2024, through June 30, 2025.

34 SECTION 3. REAPPROPRIATION AUTHORITY. There is hereby reappropriated  
 35 to the Workforce Development Council any unexpended and unencumbered bal-  
 36 ance appropriated or reappropriated to the Workforce Development Council  
 37 from the ARPA State Fiscal Recovery Fund for fiscal year 2024, to be used

1 for workforce training grants for the period July 1, 2024, through June 30,  
2 2025. The Office of the State Controller shall confirm the reappropriation  
3 amounts, by fund and expense class, with the Legislative Services Office  
4 prior to processing the reappropriation authorized herein.

5 SECTION 4. REAPPROPRIATION AUTHORITY. There is hereby reappropriated  
6 to the Workforce Development Council any unexpended and unencumbered bal-  
7 ance appropriated or reappropriated to the Workforce Development Council  
8 from the ARPA State Fiscal Recovery Fund for fiscal year 2024, to be used  
9 for childcare infrastructure grants for the period July 1, 2024, through  
10 June 30, 2025. The Office of the State Controller shall confirm the reappro-  
11 priation amounts, by fund and expense class, with the Legislative Services  
12 Office prior to processing the reappropriation authorized herein.

13 SECTION 5. REAPPROPRIATION AUTHORITY. There is hereby reappropriated  
14 to the Workforce Development Council any unexpended and unencumbered bal-  
15 ance appropriated or reappropriated to the Workforce Development Council  
16 from the In-Demand Careers Fund for fiscal year 2024, to be used for Idaho  
17 Launch grants for the period July 1, 2024, through June 30, 2025. The Office  
18 of the State Controller shall confirm the reappropriation amounts, by fund  
19 and expense class, with the Legislative Services Office prior to processing  
20 the reappropriation authorized herein.

21 SECTION 6. REAPPROPRIATION AUTHORITY. There is hereby reappropriated  
22 to the Workforce Development Council any unexpended and unencumbered bal-  
23 ance appropriated or reappropriated to the Workforce Development Council  
24 from the Workforce Development Training Fund for fiscal year 2024, to be  
25 used for semiconductor grants for the period July 1, 2024, through June 30,  
26 2025. The Office of the State Controller shall confirm the reappropriation  
27 amounts, by fund and expense class, with the Legislative Services Office  
28 prior to processing the reappropriation authorized herein.

29 SECTION 7. An emergency existing therefor, which emergency is hereby  
30 declared to exist, this act shall be in full force and effect on and after  
31 July 1, 2024.
