Be it enacted by the People of the State of Illinois, represented in the General Assembly:

ARTICLE 1

5	Section 5. The following named amounts, or so much thereof
6	as may be necessary respectively, are appropriated to the

1 Section 10. The sum of \$17,200,000, or so much thereof as 2 may be necessary, is appropriated from the Federal Support 3 Agreement Revolving Fund to the Department of Military Affairs 4 Facilities Division for expenses related to Army National Guard 5 Facilities operations and maintenance as provided for in the 6 Cooperative Funding Agreements, including prior years' costs.

Section 15. The sum of \$35,000, or so much thereof as may be necessary, is appropriated from the General Revenue Fund to the Department of Military Affairs Office of the Adjutant General Division for expenses related to the care and preservation of historic artifacts.

12 Section 20. The sum of \$1,000,000, or so much thereof as 13 may be necessary, is appropriated from the Military Affairs 14 Trust Fund to the Department of Military Affairs Office of the 15 Adjutant General Division to support youth and other programs, 16 provided such amounts shall not exceed funds to be made 17 available from public or private sources.

18 Section 25. The sum of \$5,000,000, or so much thereof as 19 may be necessary, is appropriated from the Illinois Military 20 Family Relief Fund to the Department of Military Affairs Office 21 of the Adjutant General Division for the issuance of grants to 22 persons or families of persons who are members of the Illinois

Section 30. The sum of \$800,000, or so much thereof as may
be necessary, is appropriated from the General Revenue Fund to
the Department of Military Affairs for deposit into the Federal
Support Agreement Revolving Fund.

9 Section 35. The sum of \$100,000, or so much thereof as may 10 be necessary, is appropriated from the State Military Justice 11 Fund to the Department of Military Affairs for expenses of 12 military justice as provided in the Illinois Code of Military 13 Justice.
